REAPPROPRIATION. There is hereby appropriated, to the State 15 Insurance Department, to be payable from the General Improvement Fund or its 16 successor fund or fund accounts, for the State Insurance Department, the 17 following: (A) Effective July 1, 1991, the balance of the appropriation provided 18 19 in Item (A) of Section 1 of Act 55 of the First Extraordinary Session of 1989, 20 for the purchase of computer equipment, in a sum not to exceed \$48,400. 21 22 SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor 23 obligations otherwise incurred in relation to the project or projects 24 described herein in excess of the State Treasury funds actually available 25 therefor as provided by law. Provided, however, that institutions and 26 agencies listed herein shall have the authority to accept and use grants and 27 donations including Federal funds, and to use its unobligated cash income or 28 funds, or both available to it, for the purpose of supplementing the State 29 Treasury funds for financing the entire costs of the project or projects 30 enumerated herein. Provided further, that the appropriations and funds 31 otherwise provided by the General Assembly for Maintenance and General 32 Operations of the agency or institutions receiving appropriation herein shall 33 not be used for any of the purposes as appropriated in this Act. Any restrictions contained in the Acts enumerated in the 34 35 reappropriation sections of this Act, the restrictions of any applicable

36 provisions of the State Purchasing Law, the General Accounting and Budgetary

- 1 Procedures Law, the Revenue Stabilization Law and any other applicable fiscal
- 2 control laws of this State and regulations promulgated by the Department of
- 3 Finance and Administration, as authorized by law, shall be strictly complied
- 4 with in disbursement of any funds provided by this Act unless specifically
- 5 provided otherwise by law.

- 7 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
- 8 Assembly that any funds disbursed under the authority of the appropriations
- 9 contained in this Act shall be in compliance with the stated reasons for which
- 10 this Act was adopted, as evidenced by the Agency Requests, Executive
- 11 Recommendations and Legislative Recommendations contained in the budget
- 12 manuals prepared by the Department of Finance and Administration, letters, or
- 13 summarized oral testimony in the official minutes of the Arkansas Legislative
- 14 Council or Joint Budget Committee which relate to its passage and adoption.

- 16 SECTION 4. CODE. All provisions of this Act of a general and permanent
- 17 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
- 18 Code Revision Commission shall incorporate the same in the Code.

19

- 20 SECTION 5. SEVERABILITY. If any provision of this Act or the
- 21 application thereof to any person or circumstance is held invalid, such
- 22 invalidity shall not affect other provisions or applications of the Act which
- 23 can be given effect without the invalid provision or application, and to this
- 24 end the provisions of this Act are declared to be severable.

- 26 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
- 27 with this Act are hereby repealed.

- 29 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
- 30 Seventy-Eighth General Assembly, that the Constitution of the State of
- 31 Arkansas prohibits the appropriation of funds for more than a two (2) year
- 32 period; that previous General Assemblies have provided appropriations for the
- 33 projects provided enumerated in this act; that certain appropriations will
- 34 expire before the adjournment of the General Assembly; and that if such
- 35 appropriations expire, the projects and programs authorized herein will cease

1 thereby depriving the citizens of the State of the benefits to be derived from
 2 such projects. Therefore, an emergency is hereby declared to exist and this
 3 Act being necessary for the immediate preservation of the public peace, health
 4 and safety shall be in full force and effect from and after the date of its
 5 passage and approval.
