16	SECTION 1. Chapter 67 of Title 23 of the Arkansas Code is hereby

18	"23-67-201. This Act shall be known and cited as the "Arkansas Workers
19	Compensation Insurance Plan.

21	23-67-202. Purpose.
22	The purpose of this Act is to amend Title 23 of Arkansas Code Annotated
23	of 1987 to provide for the establishment of a mandatory workers' compensation
24	insurance plan to assure coverage for employers who are in good faith
25	entitled, but unable to procure, workers' compensation insurance in this
26	State, and to provide that the operation and regulation of the Arkansas
27	Workers' Compensation Insurance Plan shall be the responsibility of the
28	Insurance Commissioner.
29	
30	23-67-203. Establishment, Operation and Regulation.
31	The Insurance Commissioner shall be responsible for the establishment,
32	operation and regulation of the Arkansas Workers' Compensation Insurance Plan
33	pursuant to the provisions of this Act.

35	23-67-204. Plan for Coverage.

- 1 (1) The Arkansas Workers' Compensation Insurance Plan shall give
- 2 consideration to:
- 3 (a) the need for adequate and readily accessible coverage;
- 4 (b) optional methods of improving the market affected;
- 5 (c) the need for reasonable underwriting standards;
- 6 (d) the need for adequate supervisory and servicing procedures to
- 7 ensure proper operation of the Plan;
- 8 (e) the need to establish procedures that will have minimum
- 9 interference with the voluntary market;
- 10 (f) distributing the obligations imposed by the Plan and any profits or

Cancellation of Policy. If, after the issuance of a policy providing insurance pursuant to the 23

24 provisions of this Act, the insurer which issued the policy finds that the 25 employer to whom he policy was issued is not or has ceased to be entitled to 26 the insurance, the insurer shall have the right to cancel the policy in 27 accordance with Arkansas Code Annotated § 11-9-408(b).

If any insurer refuses or neglects to comply with the provisions of this 30 31 Act or with any order or ruling made by the Commissioner pursuant to this Act,

32 the insurer shall be subject to the administrative penalties provided for in

33 the Insurance Code.

Any person aggrieved by an order or ruling made by the Commissioner

         The Insurance Commissioner is authorized to promulgate such reasonable
 7 rules and regulations as are necessary to carry out the provisions of this
 8 Act."

         SECTION 2. All provisions of this Act of a general and permanent nature

11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
12 Revision Commission shall incorporate the same in the Code.

         SECTION 3. If any provision of this Act or the application thereof to
15 any person or circumstance is held invalid, such invalidity shall not affect
16 other provisions or applications of the Act which can be given effect without
17 the invalid provision or application, and to this end the provisions of this
18 Act are declared to be severable.

         SECTION 4. (a) Arkansas Code 11-9-409 is hereby repealed.
             All laws and parts of laws in conflict with this Act are hereby

         SECTION 5. EMERGENCY CLAUSE. It is hereby found and determined by the

25 General Assembly that the workers' compensation risk pool is being transferred
26 by this Act from the Workers' Compensation Commission to the Insurance
27 Department; that the transfer should become effective at the beginning of the
28 next fiscal year in order to comport with the appropriations for the next
29 fiscal year for the Workers' Compensation Commission and the Insurance
30 Department; that this Act may not go into effect on July 1, 1991 unless this
31 emergency clause is adopted. Therefore, an emergency is hereby declared to
32 exist and this Act being immediately necessary for the preservation of the
33 public peace, health and safety shall be in full force and effect from and
34 after July 1, 1991.
