19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20	
21	SECTION 1. Arkansas Code Annotated §17-34-110(b) is amended to read as
22	follows:
23	"(b) Each contract between a charitable organization and a professional
24	fund raiser shall require delivery of the gross collections of any promotion
25	to the charitable organization or its designated representatives, and shall
26	require delivery of the names and addresses of all persons making
27	contributions and the amounts thereof to the charitable organization."
28	
29	SECTION 2. From and after the effective date of this act, all
30	professional fund raisers shall provide the names and addresses of all persons
31	making contributions and the amounts thereof to the charitable organization
32	for which the funds were solicited.
33	
34	SECTION 3. All provisions of this act of a general and permanent nature
35	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
36	Revision Commission shall incorporate the same in the Code.

2 SECTION 4. If any provision of this act or the application thereof to 3 any person or circumstance is held invalid, such invalidity shall not affect 4 other provisions or applications of the act which can be given effect without 5 the invalid provision or application, and to this end the provisions of this 6 act are declared to be severable.

SECTION 5. All laws and parts of laws in conflict with this act are 8 9 hereby repealed.

11 SECTION 6. EMERGENCY. It is hereby found and determined by the General 12 Assembly of the State of Arkansas that in order to protect the interests of 13 the public and legitimate charitable organizations from the misrepresentations 14 made by certain fund raisers who solicit funds in the name of certain 15 charitable organizations but do not disclose contributors and the amounts of 16 the contributions to those organizations there is a need for an accounting of 17 contributors and contributions by the fund raisers. Therefore, an emergency 18 is hereby declared to exist and this act being necessary for the immediate 19 preservation of the public peace, health, and safety, shall be in full force 20 and effect from and after its passage and approval.
