| 17 | BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS: |

| 19 | SECTION 1. Arkansas Code §24-11-802 is hereby amended to read as follows: |
| 20 | "24-11-802. Board of trustees - Proceedings. |
| 21 | (a) The board shall hold such meetings as required by this section and upon the call of |
| 22 | its president at such other times as the president deems necessary. |
| 23 | (b) It shall issue orders signed by the president and secretary to the persons entitled |
| 24 | thereto for the amount of money ordered paid to the persons from the fund by the board, which |
| 25 | order shall state for what purpose the payment is made. |
| 26 | (c) It shall keep a record of its proceedings, which record shall be a public record. |
| 27 | (d) At each meeting, it shall send to the treasurer of the city or town a written or |
| 28 | printed list of all persons entitled to payment from the fund provided for in this subchapter. |
| 29 | This list shall state the amount of the payment and for what granted and shall be certified to |
| 30 | and signed by the president and secretary of the board and attested under oath. |
| 31 | (e) The treasurer of the city or town shall thereupon enter a copy of the list upon the |
| 32 | book to be kept for that purpose, which book shall be known as _The Firemen's Relief and |
| 33 | Pension Fund Book,_ and the board shall direct payment of the amounts named therein to the |
| 34 | persons entitled thereto out of those funds. |
| 35 | (f) A majority of all the members of the board shall constitute a quorum and shall have |
| 36 | the power to transact business. |

(g) No money belonging to the fund shall ever be disbursed for any purpose without a 1 vote of a majority of all the members of the board of trustees, which shall be taken by the yeas 2 and nays, and the vote of each member so voting shall be entered upon the proceedings of the 3 board. 4 (h) The firemen's relief and pension fund board for towns and second-class cities shall 5 6 meet on the first Monday of each quarter for a total of at least four (4) meetings per year. The firemen's relief and pension fund board for first-class cities may meet monthly on the first 7 Monday of each month, but shall meet at least quarterly on the first Monday of each quarter 8 for a total of at least four (4) meetings per year. 9 (i) The firemen's relief and pension fund board for first and second-class cities and 10 incorporated towns shall have the option to designate a night other than Monday for their 11 required meetings, which designation shall be contained in the minutes and records of the 12 board meetings." 13 14 15 SECTION 2. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision 16 Commission shall incorporate the same in the Code. 17 18 SECTION 3. If any provision of this act or the application thereof to any person or 19 circumstance is held invalid, such invalidity shall not affect other provisions or applications of 20 21 the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable. 2.2 23 SECTION 4.
