For An Act To Be Entitled

8 "TO AMEND ARKANSAS CODE 27-72-302 (b) TO INCREASE THE
9 MAXIMUM TOTAL MILEAGE IN THE STATE AID ROAD SYSTEM FROM
10 10,000 MILES TO 15,000 MILES; AND FOR OTHER PURPOSES."

13 **"TO INCREASE THE MAXIMUM TOTAL MILEAGE IN THE**
14 **STATE AID ROAD SYSTEM FROM 10,000 MILES TO 15,000**
15 **MILES."**

17 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:**

19 **SECTION 1. Arkansas Code 27-72-302(b) is hereby amended to read as follows:**

20 **"(b) There is set up for designation by cooperative action of the state and counties a**
21 **state aid system of roads, as classified and defined in this subchapter, which system shall be**
22 **designated by the several county judges of their respective counties with the consent and**
23 **approval of the state aid engineer and the State Highway Commission to a total mileage not in**
24 **excess of fifteen thousand (15,000) miles including any municipal streets, and initially**
25 **established at five thousand (5,000) miles, which five thousand (5,000) miles shall include all**
26 **county roads on the federal-aid secondary road system. The system will periodically be**
27 **expanded in one thousand-mile increments after the initial five thousand-mile system has been**
28 **established."**

30 **SECTION 2. All provisions of this act of a general and permanent nature are**
31 **amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision**
32 **Commission shall incorporate the same in the Code.**

34 **SECTION 3. If any provision of this act or the application thereof to any person or**
35 **circumstance is held invalid, such invalidity shall not affect other provisions or applications of**
36 **the act which can be given effect without the invalid provision or application, and to this end**

1 **the provisions of this act are declared to be severable.**

3 **SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.**

5 **SECTION 5. It is hereby found and determined by the General Assembly that there is**
6 **an urgent need for a periodic expansion of the state aid road system; that the current law limits**
7 **the system to a total mileage of ten thousand (10,000) miles; that this act is designed to**
8 **increase the maximum total mileage in the system and should be given effect immediately.**

9 **Therefore, an emergency is hereby declared to exist, and this act being immediately necessary**
10 **for the preservation of the public peace, health and safety shall be in full force and effect from**
11 **and after its passage and approval.**
