APPROPRIATIONS. There is hereby appropriated, to the Petit Jean 21 Technical College, to be payable from the Petit Jean Technical College Fund, for the purchase of library holdings of the Petit Jean Technical College which shall be supplemental and in 23 addition to those funds appropriated in Section 1 of Act 940 of 1991, for the remainder of the 25 biennial period ending June 30, 1993, the following: 26 27 **ITEM** FISCAL YEAR NO. 1992-93 28 (01) PURCHASE LIBRARY HOLDINGS \$ 1,156 29 3 0 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 31 authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State 34 Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue 35 Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education 36 Expenditure Restrictions Act, or their successors, and other fiscal control laws of this State,

1	where applicable, and regulations promulgated by the Department of Finance and
2	Administration, as authorized by law, shall be strictly complied with in disbursement of said
3	funds.
4	
5	SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly that
6	any funds disbursed under the authority of the appropriations contained in this Act shall be in
7	compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency
8	Requests, Executive Recommendations and Legislative Recommendations contained in the
9	budget manuals prepared by the Department of Finance and Administration, letters, or
10	summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint
11	Budget Committee which relate to its passage and adoption.
12	
13	SECTION 4. CODE. All provisions of this Act of a general and permanent nature are
14	amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision
15	Commission shall incorporate the same in the Code.
16	
17	SECTION 5. SEVERABILITY. If any provision of this Act or the application thereof
18	to any person or circumstance is held invalid, such invalidity shall not affect other provisions
19	or applications of the Act which can be given effect without the invalid provision or application,
20	and to this end the provisions of this Act are declared to be severable.
21	
22	SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict with
23	this Act are hereby repealed.
24	
25	SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
26	Seventy-Ninth General Assembly, that funds provided by the Seventy-Eighth General Assembly
27	for the operations of the Petit Jean Technical College are, due to unforeseen circumstances,
28	insufficient for the Petit Jean Technical College to continue to provide essential governmental
29	services; that the provisions of this act will provide the necessary monies for the Petit Jean
30	Technical College to continue such services; and that a delay in the effective date of this Act
31	could work irreparable harm upon the proper administration and provision of essential
32	governmental programs. Therefore, an emergency is hereby declared to exist and this Act
33	being necessary for the immediate preservation of the public peace, health and safety shall be
34	in full force and effect from and after the date of its passage and approval.
