1 State of Arkansas A Bill **ACT 280 OF 1993** 2 **79th General Assembly** HOUSE BILL 1261 Regular Session, 1993 By: Representatives Hawkins, Steele, Goodwin, and Holland 6 For An Act To Be Entitled 7 "AN ACT TO AMEND ARKANSAS CODE SECTIONS 20-22-804 AND 20g 22-805 TO CLARIFY THE POWERS AND DUTIES OF THE ARKANSAS 9 FIRE PROTECTION SERVICES BOARD; TO PROVIDE THAT THE OFFICE 10 OF FIRE PROTECTION SERVICES SHALL BE UNDER THE SUPERVISION AND DIRECTION OF THE DIRECTOR OF THE OFFICE OF EMERGENCY 12 SERVICES; AND FOR OTHER PURPOSES." 13 14 Subtitle 15 "TO CLARIFY THE POWERS AND DUTIES OF THE ARKANSAS FIRE 17 PROTECTION SERVICES BOARD." 18 19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS: 20 21 SECTION 1. Arkansas Code 20-22-804 is amended to read as follows: "20-22-804. Arkansas Fire Protection Services Board - Duties and powers. 22 The Arkansas Fire Protection Services Board shall: 23 (1) Prescribe by regulation minimum standards for the certification of 25 fire departments and standards for the classification of fire departments as 26 to their level of service including, but not limited to, standards for 27 training levels for fire fighters of fire departments, minimum levels of 28 equipment, and minimum performance standards; Establish a system of identification for fire fighters of certified 29 30 fire departments for the purpose of assisting fire fighters to carry out their 31 duties: (3) Assist fire departments with training programs and assist with the 32 33 establishment and upgrading of fire departments; (4) Promote the exchange of information among fire departments and 34 35 state agencies;

(5) Serve in an advisory capacity to the Director of the Office of

1 Emergency Services with respect to the operation of the Office of Fire 2 Protection Services; (6) Establish such other reasonable rules and regulations as may be 4 necessary for the purposes of this subchapter." 6 SECTION 2. Arkansas Code 20-22-805 is amended to read as follows: "20-22-805. Office of Fire Protection Services. There is created the Office of Fire Protection Services which shall be 9 under the supervision and direction of the Director of the Office of Emergency 10 Services. The Director of the Office of Fire Protection Services who shall be 11 employed by the Director of the Office of Emergency Services shall have the 12 responsibility to carry out the administrative functions and directives of the 13 Fire Protection Services Board. The Director of the Office of Fire Protection 14 Services may employ such personnel as may be authorized by law to carry out 15 the duties of the office." 16 SECTION 3. All provisions of this act of a general and permanent nature 17 18 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 19 Revision Commission shall incorporate the same in the Code. 20 21 SECTION 4. If any provision of this act or the application thereof to 22 any person or circumstance is held invalid, such invalidity shall not affect 23 other provisions or applications of the act which can be given effect without 24 the invalid provision or application, and to this end the provisions of this 25 act are declared to be severable. 26 SECTION 5. All laws and parts of laws in conflict with this act are 2.7 28 hereby repealed. 29 SECTION 6. EMERGENCY. It is hereby found and determined by the General 3 0 31 Assembly that the current law with respect to the relationship between the

32 Arkansas Fire Protection Services Board and the Office of Emergency Services 33 and the authority and responsibility of each agency with respect to the Office 34 of Fire Protection Services is unclear and in urgent need of clarification; 35 that this act is designed to specifically prescribe the functions and duties

1 of each of the agencies and should be given effect immediately. Therefore, an
 2 emergency is hereby declared to exist and this act being necessary for the
 3 preservation of the public peace, health and safety shall be in full force and
 4 effect from and after its passage and approval.
