3	without further publication or posting thereof. However, not less than three (3) copies of the
4	code shall be filed for use and examination by the public in the office of the clerk or recorder of
5	the municipality subsequent to the adoption thereof."
6	
7	SECTION 3. All provisions of this act of a general and permanent nature are
8	amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision
9	Commission shall incorporate the same in the Code.
10	
11	SECTION 4. If any provision of this act or the application thereof to any person or
12	circumstance is held invalid, such invalidity shall not affect other provisions or applications of
13	the act which can be given effect without the invalid provision or application, and to this end
14	the provisions of this act are declared to be severable.
15	
16	SECTION 5. All laws and parts of laws in conflict with this act are hereby repealed.
17	
18	SECTION 6. EMERGENCY. It is hereby found and determined by the General
19	Assembly that the laws of the state of Arkansas pertaining to notice of the adoption of
20	ordinances by municipalities are, in some cases, inconsistent, conflicting and confusing; that,
21	following the adoption, in 1987, of Title 19, Chapter 9, Subchapter 6 of the Arkansas Code of
22	1987 Annotated (requiring published notice and public hearing prior to the adoption of
23	ordinances authorizing revenue bonds), prior laws requiring similar notice with respect to
24	municipal waterworks revenue bonds are redundant; and that it is essential that there be no
25	confusion regarding the conduct of governmental proceedings by Arkansas municipalities.
26	Therefore an emergency is hereby declared to exist and this act being necessary for the
27	preservation of the public peace, health and safety shall be in full force and effect from and
28	after its passage and approval.
