18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. Arkansas Code 26-36-303 is hereby amended to read as follows:	
21	"26-36-303. Definitions. As used in this subchapter, unless the context otherwise	
22	requires:	
23	(1) _Claimant agencies_ means:	
24	(A) State-supported colleges and universities;	
25	(B) The Department of Human Services;	
26	(C) The Arkansas Student Loan Authority;	
27	(D) The Student Loan Guarantee Foundation of Arkansas;	
28	(E) The Auditor of State; and	
29	(F) The Department of Higher Education;	
30	(2) _Debtor_ means any individual owing money to or having a delinquent account	
31	with any claimant agency, which obligation has not been adjudicated, satisfied by court order,	
32	set aside by court order, or discharged in bankruptcy;	
33	(3)(A) _Debt_ means any liquidated sum due and owing any claimant agency which ha	ıs
34	accrued through contract, subrogation, tort, operation of law, or any other legal theory,	
35	regardless of whether there is an outstanding judgment for that sum.	
36	(B) _Debt_ shall include accrued obligations due to an assignment of child	

1	support rights made to the state as a condition of eligibility for welfare assistance and those
2	which have accrued from contract with the claimant agency by an individual who is not the
3	recipient of welfare assistance.
4	(C) _Debt_ shall also include the owing of money to a claimant agency as result
5	of a debtor cashing both the original and the duplicate state warrants;
6	(4) _Division_ means the Revenue Division of the Department of Finance and
7	Administration;
8	(5) _Refund_ means the Arkansas income tax refund which the division determines to
9	be due any individual taxpayer, less any amounts determined by the division to be due to the
L O	division for payment of any state tax as defined in the Arkansas Tax Procedure Act, as
L1	amended, <b>§ 26-18-101</b> et seq.;
L2	(6) _Setoff_ means withholding of part or all of income tax refunds due individuals who
L3	owe debts to the State of Arkansas."

L5	SECTION 2. All provisions of this act of a general and permanent nature are
L6	amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision
L7	Commission shall incorporate the same in the Code.

L9	SECTION 3. If any provision of this act or the application thereof to any person or
20	${\bf circumstance}\ is\ held\ invalid,\ such\ invalidity\ shall\ not\ affect\ other\ provisions\ or\ applications\ of$
21	the act which can be given effect without the invalid provision or application, and to this end
22	the provisions of this act are declared to be severable.

24	SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.
