25	(a) The Arkansas Workers' Compensation Commission is hereby authorized
26	to recognize an entity formed under the Arkansas Nonprofit Corporation Act, §§
27	4-28-201 - 4-28-206 and §§ 4-28-209 - 4-28-223, to function as the guaranty
28	fund for Arkansas workers' compensation self-insurers in the private sector.
29	(b) Public sector self-insurers are specifically exempted from the
30	provisions of this subchapter.
31	(c) As used in this subchapter, _Public sector self insurer_ means a
32	group of municipalities, a city, a county, or the state entity which directly
33	exercises control over an employee and which pays the employee_s salary."

35	SECTION 2. All provisions of this act of a general and permanent
36	nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
