19	SECTION 1. Since the purple martin, a	bird known for its appetite for
20	flying insects, is deemed by most as an attr	active asset for its appearance,
21	song, cleanliness, and diet (America's Most	Wanted Bird) and since the city of
22	Lake Village in Chicot County, of southeaste	rn Arkansas is located along the
23	North-South Flyway, the major migration rout	e for millions of birds, the city
24	of Lake Village in Chicot County, Arkansas,	shall be designated by the
25	Arkansas General Assembly to be known as the	Southeast Purple Martin Capital
26	of the State of Arkansas.

28	SECTION 2. All provisions of this act	of a general and permanent nature
29	are amendatory to the Arkansas Code of 1987	Annotated and the Arkansas Code
30	Revision Commission shall incorporate the sa	me in the Code.

32	SECTION 3. If any provision of this a	ct or the application thereof to
33	any person or circumstance is held invalid,	such invalidity shall not affect
34	other provisions or applications of the act	which can be given effect without
35	the invalid provision or application, and to	this end the provisions of this
36	act are declared to be severable

         SECTION 4. All laws and parts of laws in conflict with this act are

 3 hereby repealed.

         SECTION 5. Emergency. It is hereby found and determined by the
 6 Seventy-Ninth General Assembly of the State of Arkansas that the purple martin
 7 is a bird known for its hearty appetite for mosquitoes and other flying
 8 insects and is deemed an attractive asset because of its appearance, song,
 9 cleanliness, and diet, and that the city of Lake Village in southeastern
10 Arkansas is located along the North-South Flyway where millions of birds
11 migrate annually, and that designating the city of Lake Village as the
12 Southeast Purple Martin Capital of Arkansas will economically benefit the area
13 by attracting tourists to the area and by gaining it recognition as a prime
14 birding hotspot. Therefore, in order to economically aid the city of Lake
15 Village, an emergency is hereby declared to exist, and this act being
16 necessary for the immediate preservation of the public peace, health, and
17 safety, shall be in full force and effect from and after its passage and
18 approval.
