20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	SECTION 1. The double-crested cormorant is hereby declared a nuisance
23	and the Arkansas Game and Fish Commission is requested to work with the U.S.
24	Fish and Wildlife Service and the Arkansas congressional delegation to permit
25	bona fide fish farmers and other owners of private lakes in Arkansas to
26	eliminate depredating double crested cormorants under such terms as may be
27	agreed upon by the Arkansas Game and Fish Commission and the U.S. Fish and
28	Wildlife Service.
29	
30	SECTION 2. All provisions of this act of a general and permanent nature
31	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
32	Revision Commission shall incorporate the same in the Code.
33	
34	SECTION 3. If any provision of this act or the application thereof to
35	any person or circumstance is held invalid, such invalidity shall not affect
36	other provisions or applications of the act which can be given effect without

1 the invalid provision or application, and to this end the provisions of this
 2 act are declared to be severable.
         SECTION 4. All laws and parts of laws in conflict with this act are
 5 hereby repealed.

 7
         SECTION 5. EMERGENCY. It is hereby found and determined by the General
 8 Assembly that fish and minnow farming is very important to the Arkansas
 9 economy; that the cormorant is inflicting serious hardship on fish and minnow
10 farmers in the state by killing and consuming large quantities of pond-raised
11 fish and minnows; that there is no practical method to protect the fish and
12 minnows from the large flocks of cormorant in the state; that this act is
13 designed to correct this undesirable situation and should be given effect
14 immediately. Therefore, an emergency is hereby declared to exist and this act
15 being necessary for the preservation of the public peace, health and safety
16 shall be in full force and effect from and after its passage and approval.
