29	grade civics and twelfth grade American Government.
30	(c) Current Arkansas laws that are the subject of the materials or
31	units shall include, but not be limited to, those dealing with school
32	attendance, penalties for truancy, requirements for obtaining a driver's
33	license and grounds for license revocation, penalties that may affect
34	juveniles who engage in criminal activities, and those that authorize local
35	ordinances such as curfews.

1 reproduced and sent to all school districts in the state by no later than 2 August 1, 1996, and are updated after each Regular Session of the Arkansas 3 General Assembly. (e) During each biennium, the director shall provide a progress report 4 5 on the implementation of this act to the Joint Interim Committee on Education. 6 7 SECTION 2. All provisions of this act of a general and permanent nature 8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 9 Revision Commission shall incorporate the same in the Code. 10 11 SECTION 3. If any provision of this act or the application thereof to 12 any person or circumstance is held invalid, such invalidity shall not affect 13 other provisions or applications of the act which can be given effect without 14 the invalid provision or application, and to this end the provisions of this 15 act are declared to be severable. 16 SECTION 4.
