18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. Arkansas Code § 19-4-1602 is amended to read as follows:
21	"19-4-1602. Payroll deductions.
22	(a) Deductions from the payrolls of state employees, both regular and
23	extra help, shall be permitted only for the following purposes:
24	(1) Withholding taxes;
25	(2) Social security contributions;
26	(3) Contributions to any state retirement system or approved plan
27	of deferred compensation;
28	(4) Group hospital, medical, and life insurance deductions.
29	However, any payroll deductions through the Arkansas state mechanized payroll
30	system for state employees for coverages other than the state authorized plan
31	shall be approved by the State Employees Insurance Advisory Committee;
32	(5) Payments to state employees' credit unions;
33	(6) Value of maintenance perquisites;
34	(7) Payment of union dues, when requested in writing by state
35	employees;
36	(8) Purchase of United States Government savings bonds;

1 (9) Arkansas State Employees' Association, Inc., dues, when 2 requested in writing by state employees; ٦ (10) Fees for participation in the State Employees Benefit 4 Corporation, when requested in writing by the State employees; Contributions to the major federated fund-raising 5 (11)6 organization, when authorized by state employees; 7 (12) Arkansas State Police Association dues, when authorized in 8 writing by state employees; Fraternal Order of Police dues, when requested in writing by 9 (13) 10 state employees; 11 (14) Arkansas Rehabilitation Association dues, when authorized in 12 writing by state employees; and (15) For such other purposes as are specifically authorized by 13 14 law but not enumerated in this subsection. 15 (b) Deductions as are authorized by this section shall be made in 16 compliance with rules, regulations, and procedures established by the Chief 17 Fiscal Officer of the State." 18 19 SECTION 2. All provisions of this act of general and permanent nature 20 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 21 Revision Commission shall incorporate the same in the Code. 22 SECTION 3. If any provisions of this act or the application thereof to 23 24 any person or circumstance is held invalid, the invalidity shall not affect 25 other provisions or applications of the act which can be given effect without 26 the invalid provisions or application, and to this end the provisions of this 27 act are declared to be severable. 28 SECTION 4.
