| 20 | SECTION 1. Arkansas Code Annotated § 9-14-210(c) is hereby amended to          |

| 22 | "(c) An attorney employed under this subchapter, whether directly or by        |
| 23 | contract with the Office of Child Support Enforcement, may be designated a     |
| 24 | special deputy prosecutor by the prosecuting attorney of that judicial         |
| 25 | district, for the limited purposes of prosecuting in a court of competent      |
| 26 | jurisdiction actions brought under § 5-26-401 or § 5-54-102, in those cases    |
| 27 | proceeding under Title IV-D of the Social Security Act. However, nothing in    |
| 28 | this section shall be construed to entitle such attorneys to those rights,     |
| 29 | benefits, or privileges which accrue to a prosecuting attorney under any other |
| 30 | provision of state law, except as set forth below:                             |
| 31 | (1) As a special deputy prosecutor, such attorney shall have the               |
| 32 | power to issue subpoenas in all matters being investigated by the Office of    |
| 33 | Child Support Enforcement under § 5-26-401 or § 5-54-102 and may administer    |
| 34 | oaths for taking the testimony of witnesses subpoenaed before them. Such       |
| 35 | oaths shall have the same effect as if administered by the foreman of a grand  |

               (2) A special deputy prosecutor appointed and functioning as

 3 authorized under this section shall be entitled to the same immunity granted
 4 by law to the prosecuting attorney. The prosecuting attorney may revoke the
 5 appointment of a special deputy prosecutor at any time.
               (3) Appointment as a special deputy prosecutor shall not entitle
 7 such attorney to receive any additional fees or salary from the State for

         SECTION 2. All provisions of this act of a general and permanent nature
14 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
15 Revision Commission shall incorporate the same in the Code.
