18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19	
20	SECTION 1. Ark. Code 6-17-204(a) and (b) is amended to read as follows:
21	"(a) The personnel policies of each school district properly adopted
22	under Ark. Code §§ 6-17-201 - 208 shall be considered to be incorporated as
23	terms of the certified personnel contracts and shall be binding upon the
24	certified personnel and the district.
25	(b) Any changes or additions to the personnel policies shall be
26	considered a part of certified personnel contracts for the next fiscal year
27	provided that they are made in accordance with Ark. Code § 6-17-201, et seq.
28	(c) Any changes or additions to the personnel policies may take effect
29	before the next fiscal year only if the changes or additions are made in
30	accordance with Ark. Code §§ 6-17-201, et seq. and if the changes or additions
31	are approved by a majority of the certified personnel employed by the district
32	voting by secret ballot. The voting and counting shall be conducted by
33	personnel policy committee.
34	(d) No certified person may waive payment according to the salary
35	schedule.
36	(e) A district may adopt a uniform policy, in accordance with § 6-17-

1 201 et seq., limiting the number of past years' experience for which all 2 newly-employed certified personnel will receive credit on the salary schedule. 3 The policy shall be written so that a prospective certified employee can 4 determine his or her placement on the salary schedule. (f) A school district shall adopt, in accordance with § 6-17-201 et 6 seq., a supplement to the salary schedule for those certified staff employed 7 longer than the period covered by the salary schedule and for duties in 8 addition to certified employees' regular teaching assignments. (g) Compensation policies approved by the personnel policy committee 10 shall not apply to the chief administrator who is charged with administration 11 of salary policy for all employees." 12 13 SECTION 2. All provisions of this act of a general and permanent nature 14 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 15 Revision Commission shall incorporate the same in the Code. 16 SECTION 3. If any provision of this act or the application thereof to 17 18 any person or circumstance is held invalid, such invalidity shall not affect 19 other provisions or applications of the act which can be given effect without 20 the invalid provision or application, and to this end the provisions of this 21 act are declared to be severable. 22 SECTION 4.
