The General Assembly has determined that, pursuant to 22 Arkansas Forestry Commission policy, county foresters and district foresters 23 employed by the Arkansas Forestry Commission are required to have earned the 24 minimum of a bachelor s defree in forestry from an accredited, four-year 25 program at an institution of higher education. The General Assembly has 26 further determined that the State Forester should also be required to have 27 earned at a minimum a bachelor s degree in forestry from an accredited, four-28 year program at an institution of higher education. 29 3.0 SECTION 2. Arkansas Code Annotated § 15-31-104 is amended to read as 31 follows: "15-31-104. State Forester. 32 The State Forester shall: 33 (1) Be employed by the State Forestry Commission, with the approval of 34 35 the Governor, and shall serve at the pleasure of the Governor; 36 (2) Administer the provisions of this chapter and the rules, regulations,

- 1 and orders established thereunder. The commission may, by adopted resolution,
- 2 delegate to the State Forester any of the powers or duties vested in or
- 3 imposed upon it by this chapter. Such delegated powers and duties may be
- 4 exercised by the State Forester in the name of the commission;
- 5 (3) Be a person who shall have earned at a minimum a bachelor s degere in
- 6 forestry from an accredited, four-year program at an institution of higher
- 7 education and have not less than three (3) years' practical administrative and
- 8 field experience in forestry;
- 9 (4) Be custodian of all property held in the name of the commission and
- 10 shall be, ex officio, the disbursing agent of all funds available for its use;
- 11 and
- 12 (5) Furnish bond to the state, with a corporate surety thereon, in the
- 13 penal sum of twenty-five thousand dollars (\$25,000), conditioned that he will
- 14 faithfully perform his duties of employment and properly account for all funds
- 15 received and disbursed by him. An additional disbursing agent's bond shall not
- 16 be required of the State Forester. The bond shall be filed with the Secretary
- 17 of State, and an executed counterpart thereof shall be filed with the Auditor
- 18 of State."

- 20 SECTION 3. All provisions of this act of a general and permanent nature
- 21 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 22 Revision Commission shall incorporate the same in the Code.

- 24 SECTION 4. If any provision of this act or the application thereof to
- 25 any person or circumstance is held invalid, such invalidity shall not affect
- 26 the invalid provision or application, and to this end the provisions of this
- 27 act are declared to be severable.

- 29 SECTION 5. All laws and parts of laws in conflict with this act are
- 30 hereby repealed.
