17	"TO MERGE AND RE-NAME CERTAIN DIVISIONS

21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code § 25-10-102 is amended to read as follows:
24	"25-10-102. Organization generally.
25	(a) The Department of Human Services shall consist of, and be operated
	under, an integrated service system consisting of the following ten (10)
	divisions with responsibility and programs assigned to them as determined by
28	the Director of the Department of Human Services:
29	(1) A Division of Children and Family Services;
30	(2) A Division of Aging and Adult Services;
31	(3) A Division of Medical Services;
32	(4) A Division of Mental Health Services, which shall include
	both community mental health centers and state hospitals;
34	(5) A Division of Developmental Disabilities Services, which
	shall include both community programs and human development centers;
36	(6) A Division of County Operations:

- 1 (7) A Division of Administrative Services; 2 (8) A Division of Youth Services, which shall include serious 3 offender and community based programs, and the youth service centers; (9) A Division of Volunteerism; and 4 (10) A Division of State Services for the Blind. 5 (b)(1) Each division of the Department of Human Services shall be under 7 the direction, control, and supervision of the director. The Director of the 8 Department of Human Services may, from time to time, transfer or assign 9 existing duties or new programs or duties of the department to offices, 10 sections, or units as he deems necessary for the efficient and necessary 11 operation of the department. Prior to implementation of any reorganization, 12 the Director of the Department of Human Services shall obtain the advice of 13 the Joint Interim Committee on State Agencies and Governmental Affairs. 14 (2) However, the state institutions and the operation of state 15 institutional programs under the jurisdiction of the State Hospital Board, the 16 Board of Developmental Disabilities Services, and the Arkansas Youth Services 17 Board, as provided by law, shall be under the control of their respective 18 boards. The boards shall perform their respective functions and duties under 19 the general guidelines and standards promulgated by the director of the 20 department. 21 (3) The Division of State Services for the Blind and the Board of 22 the Division of State Services for the Blind shall continue to function within 23 the Department of Human Services with the powers prescribed in Arkansas Code 24 25-10-201 et seq." 25 26 SECTION 2. Arkansas Code § 25-10-107 is amended to read as follows: "25-10-107. Reports by divisions. 2.7 28 (a) All other divisions within the Department of Human Services shall 29 provide the Division of Administrative Services with all policies regarding 30 personnel administration, procurement of commodities and services, accounting
- 31 and budget control, licensure of facilities, program planning and evaluation, 32 contractual agreements with consultants and providers of services, data 33 processing systems management, federal grant management, and any other 34 information which may be requested by the Division of Administrative Services. 35

(b) The other divisions shall report quarterly to the Division of

1 Administrative Services concerning the areas of coordination and cooperation
 2 where the divisions have worked with other departmental divisions and
 3 concerning the plans for coordination and cooperation in the next quarter. A
 4 copy of the report shall be sent to the Arkansas Legislative Council upon
 5 request of the Council."

         SECTION 3. Any reference to the Division of Economic and Medical
 8 Services, or to the Director or Deputy Director thereof, contained in Title
 9 20, Chapter 10, of the Arkansas Code of 1987 Annotated, shall be deemed to
10 refer to the Division of Medical Services, or the Director thereof.
11
         SECTION 4. All provisions of this act of general and permanent nature
12
13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
14 Revision Commission shall incorporate the same in the Code.

         SECTION 5. If any provisions of this act or the application thereof to
17 any person or circumstance is held invalid, the invalidity shall not affect
18 other provisions or applications of the act which can be given effect without
19 the invalid provisions or application, and to this end the provisions of this
20 act are declared to be severable.

         SECTION 6. All laws and parts of laws in conflict with this act are
23 hereby repealed.
