Arkansas Code 12-30-103 is amended to read as follows: 23 "12-30-103. Workcraft program. 2.4 25 (a) The Department of Correction and the Department of Community 26 Punishment are authorized to operate a workcraft program that offers 27 instruction and training for its inmates, thereby helping prepare them for employment after incarceration. (b) The Board of Correction and Community Punishment is authorized to 29 30 establish rules and regulations for operating the program, which shall 31 include, but not be limited to, the following: (1) Acquisition of necessary machinery, materials, and equipment, 32 33 and Establishment of procedures for public sale of inmate-34 35 produced craft. 36 (3) Inmate eligibility for participation in the workcraft

2	(4) Establishment of a workcraft program revolving fund."
3	
4	SECTION 2. Arkansas Code 12-30-104 is amended to read as follows:
5	"12-30-104. Sale of workcraft items.
6	(a) The sale of items produced in the Department of Correction or the
7	Department of Correction workcraft programs may be through one (1) or more
8	retail outlets operated by the Department of Correction or the Department of
9	Community Punishment; the public availability of these items for sale will be
L O	made known through advertising and/or other public marketing communications.
L1	(b) Prices of workcraft items shall be sufficient to cover production
L2	cost. A percentage of sale proceeds, as determined by rules and regulations
L3	will accrue to the individual product - creating inmate_s account and the
L4	remainder to a workcraft program revolving fund."
L5	
L6	SECTION 3. All provisions of this act of a general and permanent nature
L7	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
L8	Revision Commission shall incorporate the same in the Code.
L9	
20	SECTION 4. If any provision of this act or the application thereof to
21	any person or circumstance is held invalid, such invalidity shall not affect
22	other provisions or applications of the act which can be given effect without
23	the invalid provision or application, and to this end the provisions of this
24	act are declared to be severable.
25	
26	SECTION 5. All laws and parts of laws in conflict with this act are
27	hereby repealed.
