16	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18	SECTION 1. Arkansas Code 14-44-108(b) is amended to read as follows:
19	"(b) Any mayor may designate, at such times as he shall choose to do
20	so, any attorney regularly licensed to practice law and a resident of the
21	county in which the city or town is located, to sit in the mayor's stead as
22	judge of the city court. All fines and penalties assessed by the court in such
23	a case shall continue to be paid into the city treasury. The attorney sitting
24	in the stead of the mayor shall charge and collect the same fees as justices
25	of the peace are allowed for similar service."
26	
27	SECTION 2. Arkansas Code 14-45-106(b) is amended to read as follows:
28	"(b) Any mayor may designate, at such times as he shall choose to do
29	so, any attorney regularly licensed to practice law and a resident of the
30	county in which the city or town is located, to sit in the mayor's stead as
31	judge of the city court. All fines and penalties assessed by the court in
32	such a case shall continue to be paid into the city or town treasury. The
33	attorney sitting in the stead of the mayor shall charge and collect the same
34	fees as justices of the peace are allowed for similar service."

36	SECTION 3. All provisions of this act of a general and permanent nature

1	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
2	Revision Commission shall incorporate the same in the Code.
3	
4	SECTION 4. If any provision of this act or the application thereof to
5	any person or circumstance is held invalid, such invalidity shall not affect
6	other provisions or applications of the act which can be given effect without
7	the invalid provision or application, and to this end the provisions of this
8	act are declared to be severable.
9	
10	SECTION 5. All laws and parts of laws in conflict with this act are
11	hereby repealed.
