18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. Arkansas Code § 14-272-101 is amended to read as follows:
21	"14-272-101. Creation.
22	(a) There is hereby created the Rural Fire Departments Study
23	Commission, to be composed of sixteen (16) members to be appointed in the
24	manner and to represent various interests as follows:
25	(1) Three (3) members of the Joint Interim Committee on Insurance
26	and Commerce, one (1) to be a Senator and two (2) to be Representatives, to be
27	appointed by the cochairmen of the Joint Interim Committee on Insurance and
28	Commerce;
29	(2) Three (3) members of the Joint Interim Committee on City,
30	County, and Local Affairs, one (1) to be a Senator and two (2) to be
31	Representatives, to be appointed by the cochairmen of the Joint Interim
32	Committee on City, County, and Local Affairs;
33	(3) Two (2) members of the House of Representatives, to be
34	appointed by the Speaker of the House of Representatives;
35	(4) Two (2) members of the Senate, to be appointed by the
36	President Pro Tempore of the Senate;

- 1 (5) One (1) member representing the Arkansas Farm Bureau
- 2 Federation, to be recommended by the Arkansas Farm Bureau Federation and
- 3 appointed by the Speaker of the House of Representatives;
- 4 (6) One (1) member representing the Independent Insurance Agents
- 5 of Arkansas, to be recommended by the Independent Insurance Agents of Arkansas
- 6 and appointed by the Speaker of the House of Representatives;
- 7 (7) One (1) member representing the County Judges Association, to
- 8 be recommended by the County Judges Association and appointed by the Speaker
- 9 of the House of Representatives;
- 10 (8) One (1) member representing the Arkansas Rural Fire Fighters
- 11 Association, to be recommended by the Arkansas Rural Fire Fighters Association
- 12 and appointed by the Speaker of the House of Representatives;
- 13 (9) One (1) member representing the Arkansas Council of
- 14 Professional Fire Fighters, to be recommended by the Arkansas Council of
- 15 Professional Fire Fighters and appointed by the Speaker of the House of
- 16 Representatives;
- 17 (10) One (1) member representing the Arkansas Municipal League,
- 18 to be recommended by the Arkansas Municipal League and appointed by the
- 19 Speaker of the House of Representatives.
- 20 (b) The Speaker of the House of Representatives shall select one (1) of
- 21 the Representatives as cochairman, and the President Pro Tempore of the Senate
- 22 shall select one (1) of the Senators as cochairman.
- 23 (c)(1) A member of the commission shall continue to serve on the
- 24 commission until he or she no longer wishes to serve or no longer qualifies to
- 25 represent or is a member of the committee, body, or organization which he or
- 26 she was appointed to represent.
- 27 (2) Any vacancy on the commission shall be filled by the original
- 28 appointing authority with another qualifying member of the committee, body, or
- 29 organization."

- 31 SECTION 2. All provisions of this act of general and permanent nature
- 32 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 33 Revision Commission shall incorporate the same in the Code.

35 SECTION 3. If any provisions of this act or the application thereof to

1 any person or circumstance is held invalid, the invalidity shall not affect
 2 other provisions or applications of the act which can be given effect without
 3 the invalid provisions or application, and to this end the provisions of this
 4 act are declared to be severable.
         SECTION 4. All laws and parts of laws in conflict with this act are
