10 FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1997; AND FOR
11 OTHER PURPOSES."

Subtitle

14 "AN ACT FOR THE DEPARTMENT OF ARKANSAS
15 HERITAGE APPROPRIATION FOR THE 1995-97
16 BIENNIUM."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. REGULAR SALARIES - DIRECTOR'S OFFICE. There is hereby
21 established for the Department of Arkansas Heritage - Director's Office for
22 the 1995-97 biennium, the following maximum number of regular employees whose
23 salaries shall be governed by the provisions of the Uniform Classification and

25 laws amendatory thereto. Provided, however, that any position to which a
26 specific maximum annual salary is set out herein in dollars, shall be exempt

28 persons occupying positions authorized herein are hereby governed by the
29 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
30 Code §21-5-101), or its successor.

3 SECTION 59. APPROPRIATIONS - NATURAL AND CULTURAL RESOURCES COUNCIL -
4 STATE - OWNED LANDS OR HISTORIC SITES. There is hereby appropriated, to the
5 Department of Arkansas Heritage - Natural and Cultural Resources Council, to
6 be payable from the Arkansas Natural and Cultural Resources Grant and Trust
7 Fund, for grants for the acquisition, management, stewardship and preservation
8 of state-owned lands or historic sites of the Department of Arkansas Heritage
9 for the biennial period ending June 30, 1997, the following:

16 SECTION 60. APPROPRIATIONS - NATURAL AND CULTURAL RESOURCES COUNCIL -
17 MAIN STREET PROGRAM. There is hereby appropriated, to the Department of
18 Arkansas Heritage - Natural and Cultural Resources Council, to be payable from
19 the Natural and Cultural Resources Historic Preservation Fund, for grants for
20 the Historic Preservation Program and the Main Street Arkansas Program of the
21 Department of Arkansas Heritage for the biennial period ending June 30, 1997,
22 the following:

29 SECTION 61. No employee of the Department of Arkansas Heritage who is
30 employed as "Extra Help" may receive an amount to exceed 3/4 of the maximum
31 annual salary for a comparable position as authorized by Arkansas Code
32 21-5-201 et seq. during any fiscal year, nor may such employee be employed for
33 a period of time to exceed nine (9) months in any single fiscal year.
34 Provided, however, that no employee of the Commemorative Commission of the
35 Department of Arkansas Heritage who is employed as "Extra Help" may receive an

1 amount to exceed seventy-five percent (75%) of the maximum annual salary for a
2 comparable position as authorized by Arkansas Code 21-5-201 et seq. during any
3 fiscal year, nor shall such employee be employed for a period of time to
4 exceed fifteen hundred (1500) hours in any single fiscal year.

5

6 SECTION 62. TRANSFER OF STATE FUNDS - HISTORIC PRESERVATION PROGRAM.
7 Subject to such rules and regulations as may be implemented by the Chief
8 Fiscal Officer of the State and after seeking prior review by the Arkansas
9 Legislative Council, the Historic Preservation Officer is hereby authorized to
10 transfer funds and appropriations for Regular Salaries; Personal Services
11 Matching (Social Security, Retirement, Workmen's Compensation and Unemployment
12 Insurance); Maintenance and Operations; Grants; Conference Fees and Travel;
13 Professional Services; and Extra Help; under the various sections in this Act
14 which appropriate State Funds, whenever it appears by projecting the
15 expenditures of any of these appropriations that there will be a need of funds
16 or appropriations in one item and that there is an excess of funds or
17 appropriations in another item. The transfer of appropriations and funds
18 shall be effected only upon approval of the Chief Fiscal Officer of the State,
19 who will then authorize the State Treasurer and State Auditor to adjust the
20 affected accounts on their books of record respectively.

21

22 SECTION 63. NATURAL AND CULTURAL RESOURCES COUNCIL. The Director of
23 the Department of Arkansas Heritage shall be the disbursing officer for the
24 appropriations provided by Sections 59 and 60 of this Act. Further, if grants
25 are made to state agencies from the appropriations provided by Sections 59 and
26 60 herein, the corresponding amount of appropriation and funding of such grant
27 may be transferred to such state agency for use in classifications of
28 expenditures as determined by conditions of the grant and the state agency.

29

30 In the event that such grants make it necessary to employ additional
31 personnel, the Department of Arkansas Heritage upon seeking prior review of
32 the Chief Fiscal Officer of the State and the Arkansas Legislative Council may
33 establish one or more new additional positions at classifications and grades
34 in conformance with the Uniform Classification and Compensation Act (A.C.A.
35 22-5-201 et seq), but in no event shall the Chief Fiscal Officer of the State

1 authorize the establishment of more than six (6) regular new additional
2 positions. The Chief Fiscal Officer shall certify to the State Auditor and
3 the State Treasurer such approval of additional positions.

4

5 SECTION 64. *There is hereby appropriated, to the Department of Arkansas*
6 *Heritage - Director's Office, to be payable from the Department of Arkansas*
7 *Heritage Fund Account, for grants for the restoration of Historical Items, for*
8 *each fiscal year of the biennial period ending June 30, 1997, the sum*
9 *of.....\$50,000.*

10

11 SECTION 65. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
12 authorized by this Act shall be limited to the appropriation for such agency
13 and funds made available by law for the support of such appropriations; and
14 the restrictions of the State Purchasing Law, the General Accounting and
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
16 Procedures and Restrictions Act, or their successors, and other fiscal control
17 laws of this State, where applicable, and regulations promulgated by the
18 Department of Finance and Administration, as authorized by law, shall be
19 strictly complied with in disbursement of said funds.

20

21 SECTION 66. LEGISLATIVE INTENT. It is the intent of the General
22 Assembly that any funds disbursed under the authority of the appropriations
23 contained in this Act shall be in compliance with the stated reasons for which
24 this Act was adopted, as evidenced by the Agency Requests, Executive
25 Recommendations and Legislative Recommendations contained in the budget
26 manuals prepared by the Department of Finance and Administration, letters, or
27 summarized oral testimony in the official minutes of the Arkansas Legislative
28 Council or Joint Budget Committee which relate to its passage and adoption.

29

30 SECTION 67. CODE. All provisions of this Act of a general and
31 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the
32 Arkansas Code Revision Commission shall incorporate the same in the Code.

33

34 SECTION 68. SEVERABILITY. If any provision of this Act or the
35 application thereof to any person or circumstance is held invalid, such

1 invalidity shall not affect other provisions or applications of the Act which
2 can be given effect without the invalid provision or application, and to this
3 end the provisions of this Act are declared to be severable.

4

5 SECTION 69. GENERAL REPEALER. All laws and parts of laws in conflict
6 with this Act are hereby repealed.

7

8 SECTION 70. EMERGENCY CLAUSE. It is hereby found and determined by the
9 Eightieth General Assembly, that the Constitution of the State of Arkansas
10 prohibits the appropriation of funds for more than a two (2) year period; that
11 the effectiveness of this Act on July 1, 1995 is essential to the operation of
12 the agency for which the appropriations in this Act are provided, and that in
13 the event of an extension of the Regular Session, the delay in the effective
14 date of this Act beyond July 1, 1995 could work irreparable harm upon the
15 proper administration and provision of essential governmental programs.
16 Therefore, an emergency is hereby declared to exist and this Act being
17 necessary for the immediate preservation of the public peace, health and
18 safety shall be in full force and effect from and after July 1, 1995.
