20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	SECTION 1. Arkansas Code Annotated § 6-53-103 is hereby amended to read
23	as follows:
24	"6-53-103. Definitions.
25	As used in this chapter, unless the context otherwise requires:
26	(1) _Branch campus of the community college_ means an institution with
27	facilities located apart from the community college campus but within the
28	community college district;
29	(2) _Capital outlay expense_ means those funds devoted to or required
30	for the acquisition and improvement of land; acquisition, construction,
31	remodeling, alteration, addition, or enlargement of buildings or other
32	structures; and the initial purchase of library holdings, furniture,
33	apparatus, and other equipment for a new or expanded facility as defined by
34	the State Board. Capital outlay expense excludes those expenses used for
35	maintenance and replacement of equipment and furniture;
36	(3) _College Panel_ or _panel_ means the panel of seven (7) members of

the State Board of Higher Education including the chairman of the State Board
 of Higher Education which shall serve as the primary coordinating body for all
 two-year institutions within the system;

4 (4) _Community college_ means an institution of higher education 5 established or to be established under the provisions of this chapter 6 dedicated primarily to the educational needs of the service area, offering a 7 comprehensive program including, but without limitation, vocational, trade, 8 and technical specialty courses and programs, college transfer courses, and 9 courses in general adult education;

10 (5) _Department_ means the State Department of Higher Education; 11 (6) _District_ means the geographic area, located within one (1) or 12 more counties or cities, or any described combination thereof, or any 13 described area which may be in one (1) or more counties or parts of counties 14 but within the same service area, directly responsible for the local financial 15 support and local administration of an institution located within its service 16 area;

17 (7) _Existing community college_ means a community college established 18 in accordance with the provisions of and presently operating in conformity 19 with Arkansas Constitution, Amendment 52 and §§ 6-61-101 - 6-61-103, 6-61-201 20 - 6-61-209, 6-61-211 - 6-61-216, 6-61-301 - 6-61-306, 6-61-401, 6-61-402, 21 6-61-501 - 6-61-524, and 6-61-601 - 6-61-612;

(8) Local board means the governing body of a technical college orcommunity college;

(9) _Operating expense_ means those educational and general funds
devoted to or required for the regular or ordinary expense of the college,
including administrative, maintenance, and salary expenses, but excluding
capital outlay expenses, student activity expenses, and expense for
intercollegiate athletics. Operating expense includes maintenance and
replacement of furniture and equipment, including motor vehicles;

(10) _Satellite campus_ means an institution or off-campus facilities
31 of a community college located within a service area of a technical or
32 community college but not located within a community college district;

(11) _Service area_ means the geographic area assigned by the State
Board of Higher Education as the area to be served by the institution located
within its borders. Each county in the state shall be assigned to at least

2 (12) _State board_, _board_, or _full board_ means the State Board of 3 Higher Education comprised of the chairman, the University Panel, and the 4 College Panel;

5 (13) _System institution_ means a technical college or community6 college;

7 (14) _Technical college_ means an institution of higher education 8 established under this chapter dedicated primarily to the educational needs of 9 the service area offering a comprehensive program including, but without 10 limitation, vocational, trade, and technical specialty courses and programs, 11 courses in general adult education, and courses comparable in content and 12 quality to freshman and sophomore courses which may carry transfer credit to a 13 four-year institution in a chosen course of study;

14 (15) _University Panel_ means the panel of seven (7) members of the 15 State Board of Higher Education including the Chairman of the State Board of 16 Higher Education which shall serve as the primary coordinating body for all 17 four-year institutions within the system."

19 SECTION 2. Arkansas Code Annotated § 6-53-307 is hereby amended to read 20 as follows:

21 "6-53-307. County support of technical colleges.

(a) (1) Any county quorum court may designate all or any portion of any undedicated county sales or use tax to be used for capital improvements to or the maintenance and operation of any technical college or satellite campus of a community college.

26 (2) When the quorum court calls an election on the issue of the 27 levy of any county sales or use tax, it may also cause to be placed on the 28 ballot the issue of dedicating all or a portion of the tax for capital 29 improvements to or the maintenance and operation of any technical college or 30 satellite campus of a community college.

(b)(1) In the alternative, the quorum court may refer to a vote of the a people at any general or special election the issue of dedicating all or a portion of any undedicated county sales or use tax to any technical college or satellite campus of a community college to be used for capital improvements to or the maintenance and operation of the technical college or satellite campus

1 of a community college.

2 (2) If the voters dedicate all or a portion of the tax, it shall 3 remain so dedicated until the voters decide otherwise.

4 (c) If a technical college or satellite campus of a community college 5 for which a tax is dedicated or levied hereunder thereafter becomes a branch 6 of an existing institution of higher education, the tax dedicated or levied 7 hereunder shall continue to be dedicated and levied for the use and benefit of 8 the branch unless reduced or repealed as authorized hereunder." 9

10 SECTION 3. All provisions of this act of a general and permanent nature 11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 12 Revision Commission shall incorporate the same in the Code.

SECTION 4. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.
