	plan of the Arkansas Public Employees_ Retirement System to the
	noncontributory plan of the Arkansas Public Employees_ Retirement System prior
	to January 1, 1985, may convert from the contributory plan to the
	noncontributory plan at any time prior to June 30, 1996, in the manner
	prescribed by law for conversion before January 1, 1985."

32	SECTION 2. All provisions of this act of a general and permanent nature
33	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
	Revision Commission shall incorporate the same in the Code.

         SECTION 5. EMERGENCY. It is hereby found and determined by the General

10 Assembly that those state employees who still participate in the contributory
11 plan under the Public Employees Retirement System should be allowed to convert
12 to the noncontributory plan; that this act so provides; and that this act
13 should go into effect immediately in order to provide this option to those
14 state employees as soon as possible. Therefore, an emergency is hereby
15 declared to exist, and this act being immediately necessary for the
16 preservation of the public peace, health, and safety shall be in full force
17 and effect from and after its passage and approval.
