18	"TO CHANGE THE COMPOSITION OF THE CRIME
19	VICTIMS REPARATIONS BOARD."

21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code Annotated § 16-90-705 is amended to read as
24	follows:
25	"16-90-705. Crime Victims Reparations Board.
26	(a) There is created a Crime Victims Reparations Board consisting of
27	five (5) members appointed by the Governor with the advice and consent of the
28	Senate to serve four-year staggered terms and until the successor is appointed
29	and qualified. At least two (2) members of the board shall be persons
30	admitted to practice law in this state. At least one (1) member of the board
31	shall be a victim of criminally injurious conduct, the next of kin of a
32	homicide victim, or an individual experienced in providing victim assistance
33	services. Vacancies shall be filled in the same manner as a regular
34	appointment.
35	(b) Each year the board shall elect the chairman from its membership.
36	Members of the board shall receive no pay for their services, but each member

1 shall be entitled to reimbursement for reasonable and necessary expenses
 2 incurred in carrying out the official duties of the office, including meals,
 3 lodging, mileage, and other travel expenses. Reimbursement for expenses shall
 4 not exceed the maximums prescribed in state travel regulations for other state
 5 employees. All reasonable and necessary expenses of the board shall be paid
 6 from the Crime Victims Reparations Revolving Fund."
 7
         SECTION 2. All provisions of this act of a general and permanent nature
 9 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
10 Revision Commission shall incorporate the same in the Code.

         SECTION 3. If any provision of this act or the application thereof to
13 any person or circumstance is held invalid, such invalidity shall not affect
14 other provisions or applications of the act which can be given effect without
15 the invalid provision or application, and to this end the provisions of this
16 act are declared to be severable.

         SECTION 4. All laws and parts of laws in conflict with this act are
19 hereby repealed.
