# A Bill

**ACT 873 OF 1995**  
**HOUSE BILL 2024**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED § 27-35-210 (b) TO  
9 PROVIDE FOR THE ISSUANCE OF ANNUAL PERMITS BY THE DIRECTOR  
10 OF HIGHWAYS AND TRANSPORTATION FOR THE MOVEMENT OF WATER  
11 WELL DRILLING EQUIPMENT EXCEEDING THE LENGTH LAWS OF THIS  
12 STATE UPON THE PAYMENT OF AN ANNUAL PERMIT FEE; AND FOR  
13 OTHER PURPOSES."

## Subtitle

14  
15 "TO PROVIDE FOR ISSUANCE OF ANNUAL  
16 PERMITS FOR THE MOVEMENT OF WATER WELL  
17 DRILLING EQUIPMENT EXCEEDING THE LENGTH  
18 LAWS UPON PAYMENT OF ANNUAL PERMIT FEE."

20  
21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22  
23 SECTION 1. Arkansas Code Annotated § 27-35-210 (b) is amended to read as  
24 follows:

25 "(b) (1) (A) No application shall include nor shall any permit be issued  
26 for more than a single continuous movement or operation by one (1) vehicle.

27 (B) An application may include a request for, and a permit may  
28 be issued for, two (2) or more consecutive movements or operations by a  
29 vehicle, all of which shall be executed or performed within six (6)  
30 consecutive days and which must be limited to one (1) county within the state.

31 (2) (A) Upon application and the payment of an annual fee of one  
32 hundred dollars (\$100), the Director of Highways and Transportation shall  
33 issue a special permit for the movement of a crane exceeding the length as  
34 provided in § 27-35-208, moved on pneumatic tires within a radius of  
35 thirty-five (35) miles of a point of origin of such movement, for a period of  
36 one (1) year from the date of the issuance of the permit.

1 (B) Upon application and the payment of an annual fee, the  
2 Director of Highways and Transportation shall issue a special permit for the  
3 movement of a vehicle of special design utilized exclusively for the drilling  
4 of water wells exceeding the length as provided in § 27-35-208, moved on  
5 pneumatic tires, for a period of one (1) year from the date of issuance of the  
6 permit. For annual movements within a radius of thirty-five (35) miles of a  
7 point of origin of such movements, the annual fee shall be one hundred dollars  
8 (\$100) and for annual movements exceeding such thirty-five (35) miles radius,  
9 the annual fee shall be three hundred dollars (\$300).

10 (C) The permits authorized by this subsection may contain  
11 limitations on speed of operation and routes of operation as the director may  
12 deem necessary for safety to the traveling public.

13 (3) The permits authorized by this subsection for the overlength  
14 vehicle or vehicles shall not affect the other requirements of this section  
15 that special permits be obtained for vehicles exceeding other maximum size and  
16 weight limitations imposed by law."

17

18 SECTION 2. All provisions of this act of a general and permanent nature  
19 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
20 Revision Commission shall incorporate the same in the Code.

21

22 SECTION 3. If any provision of this act or the application thereof to  
23 any person or circumstance is held invalid, such invalidity shall not affect  
24 other provisions or applications of the act which can be given effect without  
25 the invalid provision or application, and to this end the provisions of this  
26 act are declared to be severable.

27

28 SECTION 4. All laws and parts of laws in conflict with this act are  
29 hereby repealed.
