24	SECTION 1. Arkansas Code 10-3-203(3)(A), firs	t paragraph, is amended to	
25	25 read as follows:		
26	"(3)(A) The following ten (10) subject matter interim committees of		
27	each house of the General Assembly, with the House committees to each consist		
28	of the twenty (20) members of the House of Representatives and the Senate		
29	committees to each consist of the seven (7) members of the Senate who compose		
3 0	the respective standing committees of the House and Senate having comparable		
31	l subject matter jurisdiction, plus such other non-voting members as may be		
32	e selected pursuant to rules of the House of Representatives and the Senate who		
33	shall be entitled to per diem and mileage for attending meetings of the		
34	committees. The respective House and Senate committees may meet separately o		
35	the House and Senate committees of comparable subject matter jurisdiction may		
36	86 meet jointly."		

1 SECTION 2. Arkansas Code 10-3-203(3)(B) and (C) are amended to read as 2 3 follows: "(B) Members of the ten (10) interim House committees and the ten (10) 5 interim Senate committees established in this subsection may also serve as 6 members of the Legislative Council or of the Legislative Joint Auditing 7 Committee. (C) Any member of the House of Representatives who sponsors a proposal 9 or resolution providing for a study which is referred to one (1) of the ten 10 (10) House interim committees and any member of the Senate who sponsors a 11 proposal or resolution providing for a study which is referred to one of the 12 ten (10) Senate interim committees may serve as an ex officio member of that 13 committee during the conduct of the study resulting from his proposal or 14 resolution." 15 SECTION 3. Arkansas Code 10-3-204 is amended to read as follows: 17 "10-3-204. Interim Committee Chairmen. The chairman and vice chairman of each House standing committee which 18 19 composes a House interim committee shall serve as chairman and vice chairman 20 of the House interim committee and the chairman and vice chairman of each 21 Senate standing committee which composes a Senate interim committee shall 22 serve as chairman and vice chairman of the Senate interim committee. If the 23 House and Senate interim committees of comparable subject matter jurisdiction 24 elect to meet jointly the chairman of the House committee and the chairman of 25 the Senate committee may alternately serve as chairman of the interim 26 committee in such manner as they agree." 27 SECTION 4. Arkansas Code 10-3-205 is amended to read as follows: 28 "10-3-205. Staff - Assignment and duties. 29 (a) The Director of the Bureau of Legislative Research shall have the 31 responsibility of employing the necessary professional and clerical personnel 32 to staff the interim committees. He shall, after conferring with the chairman 33 of each of the committees, assign such staff to the committees as may be 34 needed to carry out the functions and duties of the committee, within the

35 limitations of the staff available.

- Staff personnel assigned to each committee shall assist the 2 chairman of the committee in preparing agendas, notices of meetings, 3 undertaking research and writing research memoranda, taking and preparing 4 minutes, reports, and recommendations of the committee and shall provide other 5 assistance as may be necessary to assist the committee in carrying out its 6 functions and duties. If any interim committee finds that the staff assigned to that 8 committee is inadequate or that separate or additional staffing is necessary 9 on a temporary or permanent basis in order to enable the committee to carry 10 out its functions and duties, the chairman of the committee may file a request 11 for additional staff with the Director of the Bureau of Legislative Research 12 who shall present the request to the Legislative Council for its consideration 13 or the committee may request the House of Representatives or Senate to employ 14 such separate or additional staff pursuant to the authority granted in Section 15 20 of Act 1312 of 1995." 16 17 SECTION 5. Arkansas Code 10-3-206 is amended to read as follows: "10-3-206. Meetings. 18
- 19 (a) Each of the subject matter interim committees may meet at such 20 times and for such duration as it deems necessary to properly carry out its 21 functions and duties. If any committee shall find it necessary for the 22 committee to meet in excess of twelve (12) days per year, it shall report the 23 necessity for any additional meeting to the Legislative Council. If funds are 24 available to hold additional meetings, the Council shall so advise the 25 requesting committee.
- (b) The Chairman of each of the subject matter interim committees shall confer with the Director of the Bureau of Legislative Research in arranging meeting dates for the committees in order to avoid conflicting committee meetings and in order to assure maximum utilization of available staff and facilities for meetings of the committees."

32 SECTION 6. Arkansas Code 10-3-209 is amended to read as follows:

33 "10-3-209. Expenses of members.

(a) The Director of the Bureau of Legislative Research of theLegislative Council shall be the disbursing officer of the funds appropriated

1 for paying per diem, expenses, and mileage to members of the General Assembly 2 attending regular and special meetings and other committee-related activities 3 of the interim committees of the General Assembly as provided by law, unless 4 specific provisions are made to the contrary. (b) Payments for per diem and mileage for attendance by members of the 6 Senate and House of Representatives at meetings of interim committees shall be 7 upon written claims filed therefor." g SECTION 7. Arkansas Code 10-3-210(a) is amended to read as follows: 9 "(a) Members of the interim committees may be authorized to attend 11 regional or national conferences of legislators or other public officials 12 where attendance thereat will serve a beneficial legislative purpose. Members 13 shall be entitled to receive reimbursement for reasonable and necessary 14 expenses for travel, meals, lodging, and other authorized expenses incurred in 15 connection therewith." 16 SECTION 8. Arkansas Code 10-3-212(b) is amended to read as follows: 17 "(b) The members of the two (2) committees shall be entitled to receive 18 19 per diem at the rate set for attendance at meetings of the subject matter 20 interim committees of the House and Senate for attending joint or separate 21 meetings of the committees. Members shall also be entitled to mileage 22 reimbursement as provided by law." 23 SECTION 9. Arkansas Code 10-3-214(a) is amended to read as follows: 2.4 25 "(a) In addition to the functions and duties of the Legislative Council 26 which are prescribed by law, it shall be the responsibility of the Legislative 27 Council, in order to coordinate the efforts of the interim committees and to 28 avoid duplication of effort by such committees, to review and screen all study 29 resolutions referred by the General Assembly and all study proposals sponsored 30 by members of the General Assembly during the interim and approved by the 31 Legislative Council. It shall either refer the study resolutions or study 32 proposals to the appropriate interim committee for study or, in unusual cases, 33 retain the study proposal or resolution and conduct the study. Nothing in this 34 act, however, shall be construed to alter or diminish the exclusive interim 35 and presession budget jurisdiction and authority of the Legislative Council as

         SECTION 10. Arkansas Code 10-3-215 is amended to read as follows:
         "10-3-215. Study expenses.
         (a) (1) Whenever an interim committee of the Arkansas General Assembly
 6 deems it necessary or advisable, in connection with any interim study activity
 7 authorized by law or undertaken by the committee, to hire consultants,
 8 actuaries, special technical or clerical employees, or other assistance in
 9 connection with any such study, a written request shall be filed with the
10 Legislative Council. This request shall outline the nature or purposes of the
11 study, the need or necessity of hiring such special consultants, actuaries,
12 technical or clerical employees, or other assistance, and the estimated amount
13 required for the assistance.
14
                 If the Legislative Council deems that uncommitted funds are
15 available for that purpose and that the request for funds for hiring
16 consultants, actuaries, technical or clerical employees, or other assistance
17 will serve a useful purpose and that the cost is justified, the Legislative
18 Council, after seeking the advice of the interim committee which made the
19 request, may proceed to employ such consultants, actuaries, technical or
20 clerical employees, or provide other assistance and may make payment from the
21 funds appropriated for interim committee study expenses.
22
              The Legislative Council may use the funds appropriated for interim
23 committee study expenses in the same manner as other interim committees, as
24 set out in this section.
25
         (c) It is the intent of the procedures set out in this section that the
26 Legislative Council shall coordinate, control, and authorize expenditures for
27 interim committee study expenses whenever the Legislative Council deems the
28 expenditures to be in the interest of comprehensive studies or research
29 projects authorized by law or by appropriate action taken by the respective
30 interim committees."

         SECTION 11. Arkansas Code 10-3-217 is amended to read as follows:

         "10-3-217. Proposed bills - Filing - Action by committee.
             For the purpose of expediting the work of the interim committees of

35 the General Assembly and to encourage each committee to develop bills for

- 1 prompt introduction upon the convening of each session of the General
- 2 Assembly, any member of the General Assembly may file drafts of proposed bills
- 3 for consideration by the appropriate germane interim committee for study,
- 4 review, modification, and action thereon by such committee. In addition,
- 5 interim committees may cause drafts of bills to be prepared to carry out the
- 6 findings and recommendations of the interim committees which result in
- 7 recommendations for corrective or remedial legislation to be submitted to the
- 8 next-following session of the General Assembly.
- 9 (b) Proposed bills may be filed with interim committees as follows:
- 10 (1) By a member of the General Assembly filed directly with the
- 11 interim committee of which he is a member if the bill is germane to such

- 14 Legislative Council for referral to the appropriate interim committee of the

- 16 (3) By the Governor or a state agency filed with the appropriate

- 19 (c) All bills presented by the Governor and state agencies for interim
- 20 committee study shall be approved for study only upon a majority vote of the
- 21 committee, without that action creating a presumption of favorable action by
- 22 the committee on the bill, upon conclusion of its study.
- 23 (d) Bills filed directly with an interim committee shall be reviewed by
- 24 the Legislative Council for the purpose of determining that the bill is
- 25 germane to the committee, and may be re-referred to the germane interim
- 26 committee if the Legislative Council determines that the bill is not germane
- 27 to the committee with which filed.
- 28 (e) Upon conclusion of its study and hearings on a proposed bill, the
- 29 committee shall take action as follows:
- 30 (1) Upon the favorable vote of a majority of the members of the
- 31 committee or if the committee is meeting as a joint committee of the House of
- 32 Representatives and the Senate, then upon the favorable vote of a majority of
- 33 the Senate members of the committee and a majority of the House members of the
- 34 committee, approve the bill, including any amendments that may be agreed to by
- 35 the committee, for prefiling as a committee bill with the next following

1 regular session of the General Assembly; or 2. (2) Reject the proposed bill as a committee bill; or 3 (3) Take no action thereon. (f) Any bill approved by an interim committee, whether a committee of 5 one house or a joint meeting of committees of both houses, for introduction at 6 the next regular session of the General Assembly shall be prefiled as a 7 committee bill by either the House chairman or the Senate chairman of the 8 committee in the manner provided for prefiling of bills preceding the 9 convening of each regular session of the General Assembly. However, the 10 prefiling of the bill in the House of Representatives and the Senate by the 11 chairman or cochairmen of the interim committee as a committee bill shall be 12 solely for the purpose of presenting the bill to the next regular session of 13 the General Assembly for consideration in the manner provided in the rules of 14 the respective houses. The bill shall be considered by each house and by the 15 appropriate committee thereof in the same manner as other bills are considered 16 by the General Assembly. In the event an interim committee rejects a bill or fails to take 17 18 action thereon, any member of the General Assembly may introduce the bill at 19 the next regular session of the General Assembly, and the bill shall be 20 considered in the same manner as other bills introduced in the House of 21 Representatives or the Senate." 22 SECTION 12. Arkansas Code 10-3-218(b) is amended to read as follows: 23 "(b) All members of the Senate and House of Representatives who will be 2.4 25 serving in the upcoming regular biennial session of the General Assembly, 26 including the newly elected members of the Senate and House of 27 Representatives, shall be entitled to attend any or all biennial presession 28 budget hearings conducted by the Legislative Council and the Joint Budget 29 Committee and shall be entitled to receive per diem and mileage for attending 30 such meetings at the same rate as is provided for attendance at meetings of 31 interim committees of the General Assembly." 32 33 SECTION 13. Arkansas Code 10-3-219 is amended to read as follows: "10-3-219. Purpose of §§ 10-3-217 and 10-3-218. 34 It is the intent of §§ 10-3-217 and 10-3-218 to supplement the existing 35

1 laws of this state governing the powers, functions, and duties of the joint 2 interim committees of the General Assembly. Nothing in those sections is 3 intended to modify or repeal any of the existing laws governing the powers, 4 functions, and duties of any of the joint interim committees of the General 5 Assembly, including the Legislative Council and the Legislative Joint Auditing 6 Committee, except to provide for separate interim committees of the House of 7 Representatives and the Senate and to authorize comparable House and Senate 8 committees to meet jointly during the interim if they choose to do so." 9 SECTION 14. Arkansas Code 10-3-220(b) is amended to read as follows: 10 "(b) The director shall report his findings annually to the Committee 12 on Revenue and Taxation of the House of Representatives and of the Senate and 13 may make such other reports to the committees as he deems necessary." 14 15 SECTION 15. As soon as possible after the effective date of this act 16 and from time to time thereafter, the chairman and vice chairman of the 17 Legislative Council, the Speaker of the House of Representatives, and the 18 President Pro Tempore of the Senate, meeting jointly with the chairman of the 19 Joint Budget Committee shall determine the distribution of funds appropriated 20 for ad interim committees' per diem, mileage, and out-of-state travel to the 21 separate House and Senate committees herein for the remainder of this biennial 22 period. In the event that one person occupies two or more of the above named 23 positions, they shall appoint a member of their house to serve as their 24 representative in one of the positions. 25 26 SECTION 16. Nothing in this act shall affect any statutorily created 27 subcommittee of a joint interim committee. 28 SECTION 17. Arkansas Code 10-3-301(b) is amended to read as follows: 29 "(b) In order that there may be no vacancies on the Council at any 30 31 time, at the time the members are selected to the Council by the Senate and by 32 the House, there shall also be selected in the same manner, one (1) first 33 alternate member and one (1) second alternate member for each regular member. 34 First alternate members shall also be non-voting members of the Council and 35 shall be entitled to per diem and mileage for attending all meetings of the

1 Council. First alternate members of the Council shall have a vote in matters 2 before the Council if the regular member which the first alternate represents 3 is not in attendance. Second alternate members of the Council shall have a 4 vote in matters before the Council if the regular member and the first 5 alternate member which the second alternate represents are not in attendance. First alternate members attending as non-voting members of the Council shall 7 receive per diem and mileage to be paid in the same manner and from the same 8 source as regular members of the Council." 9 10 SECTION 18. Arkansas Code 10-3-403(a)(1) and (2) are amended to read as Sometime before adjournment of each regular session, the Senate 12 shall select twelve (12) members, with three (3) to be chosen from each of the 14 four (4) congressional districts in effect on January 1, 1987, by caucus of 15 the Senators residing in their respective congressional districts. At the 16 time of selecting members, the Senate shall also select in the same manner one 17 first alternate and one second alternate for each member selected and the 18 first alternate shall also be non-voting members of the Committee and shall be 19 entitled to receive per diem and mileage for attending all meetings of the 20 Committee. First alternate members of the Committee shall have a vote in 21 matters before the committee if the regular member which the first alternate 22 represents is not in attendance. Second alternate members of the Committee 23 shall have a vote in matters before the Committee if the regular member and 24 first alternate member which the second alternate represents are not in First alternate members attending as non-voting members of the 25 attendance. 26 committee shall receive per diem and mileage to be paid in the same manner and 27 from the same source as regular members of the committee. 28 The House of Representatives shall select twenty (20) members in 29 accordance with the procedure prescribed by House Rules. At the time of 30 selecting members, the House shall also select in the same manner one first 31 alternate and one second alternate for each member selected and the first 32 alternates shall also be non-voting members of the Committee and shall be 33 entitled to receive per diem and mileage for attending all meetings of the 34 Committee. First alternate members of the Committee shall have a vote in 35 matters before the committee if the regular member which the first alternate

1 represents is not in attendance. Second alternate members of the Committee 2 shall have a vote in matters before the Committee if the regular member and 3 first alternate member which the second alternate represents are not in 4 attendance. First alternate members attending as non-voting members of the 5 committee shall receive per diem and mileage to be paid in the same manner and 6 from the same source as regular members of the committee." 7 SECTION 19. Arkansas Code 10-3-502(b) and (c) are amended to read as follows: 9 The House shall select the members and their alternates in 10 11 accordance with the procedure prescribed by House Rules. The first alternate 12 members shall also be non-voting members of the Committee and shall be 13 entitled to receive per diem and mileage for attending meetings of the 14 Committee. First alternate members of the Committee shall have a vote in 15 matters before the Committee if a regular member which the first alternate 16 represents is not in attendance. Second alternate members of the Committee 17 shall have a vote in matters before the Committee if a regular member and a 18 first alternate member which the second alternate represents are not in 19 attendance. 20 (c) The Senate members of the Joint Budget Committee shall be selected 21 as follows: Five (5) members from each congressional district as they existed 22 on March 1, 1991, based on seniority within the Senate. One (1) Senate 23 alternate member shall be selected from each congressional district. 24 Alternate members shall also be non-voting members of the Committee and shall 25 be entitled to receive per diem and mileage for attending meetings of the 26 Committee. First alternate members attending as non-voting members of the 27 committee shall receive per diem and mileage to be paid in the same manner and 28 from the same source as regular members of the committee." 29 SECTION 20. Section 21 of Act 1312 of 1995 is amended to read as 30 31 follows: "Section 21. In the event that an elected constitutional officer 32 33 relocates his/her office and related staff from the State Capitol Building, 34 and does not have authorized in his/her biennial appropriation act an amount

35 sufficient to pay the moving costs, rent, costs of making necessary

1 modifications to the rented space, or other costs associated with the move,
 2 the Bureau of Legislative Research of the Arkansas Legislative Council may
 3 expend from appropriations authorized for the Bureau such additional funds as
 4 may be required to assist such elected constitutional officer in paying the
 5 additional costs. The Secretary of State and the Joint Interim Committee on

         SECTION 21. All provisions of this act of a general and permanent
10 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
11 Code Revision Commission shall incorporate the same in the Code.

         SECTION 22. If any provision of this act or the application thereof to
14
15 any person or circumstance is held invalid, such invalidity shall not affect
16 other provisions or applications of the act which can be given effect without
17 the invalid provision or application, and to this end the provisions of this
18 act are declared to be severable.

         SECTION 23. All laws and parts of laws in conflict with this act are

21 hereby repealed.

         SECTION 24. EMERGENCY. It is hereby found and determined by the
23
24 General Assembly that the current law relating to the operation of interim
25 committees of the General Assembly unduly restricts the interim work of the
26 General Assembly by authorizing committees to meet only as joint committees of
27 the House of Representatives and the Senate; that in order to enable the
28 Senate and House of Representatives to efficiently and effectively perform
29 their interim duties, it is necessary that the interim committees of each
30 house be authorized to meet either jointly or separately and that this act
31 should be given effect immediately to accomplish this purpose. Therefore, an
32 emergency is hereby declared to exist and this act being necessary for the
33 preservation of the public peace, health and safety shall be in full force and
34 effect from and after its passage and approval.
