19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
22 for the Arkansas State Building Services for the 1997-99 biennium, the
23 following maximum number of regular employees whose salaries shall be governed
24 by the provisions of the Uniform Classification and Compensation Act (Arkansas
25 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
26 Provided, however, that any position to which a specific maximum annual salary
27 is set out herein in dollars, shall be exempt from the provisions of said
28 Uniform Classification and Compensation Act. All persons occupying positions
29 authorized herein are hereby governed by the provisions of the Regular
30 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
31 successor.

SECTION 4. EXTRA HELP - BUILDING MAINTENANCE. There is hereby authorized, for the Arkansas State Building Services - Building Maintenance for the 1997-99 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: ten (10) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

13 SECTION 10. SPECIAL LANGUAGE - TRANSFER OF FUNDS. Arkansas State
14 Building Services may from time to time as may be necessary and in such
15 amounts as may be necessary and with the approval of the Chief Fiscal Officer
16 of the State, request a transfer of funds from the State Central Services Fund
17 to the Arkansas State Building Services Maintenance Fund for operation of the
18 Justice Building for actual expenditures, in an amount not to exceed the
19 dollar amount appropriated in Section 8 for each of the fiscal years. Upon
20 his approval, the Chief Fiscal Officer of the State shall then initiate the
21 necessary transfer documents to reflect the transfer upon the fiscal records
22 of the State Auditor, the State Treasurer, the Chief Fiscal Officer of the
23 State and Arkansas State Building Services.

24

25 SECTION 11. SPECIAL LANGUAGE - UNIFORMS. After seeking prior review by
26 the Arkansas Legislative Council, State Building Services may furnish uniforms
27 for Building Maintenance/Operations personnel listed as classified positions
28 in Section 3 and Section 7 herein, who are directly responsible for the
29 maintenance and operation of all State Building Services' owned buildings.

30

31 SECTION 12. APPROPRIATIONS. *There is hereby appropriated, to the*
32 *Arkansas State Building Services, to be payable from the State General*
33 *Services Fund Account, for moving and relocation expenses for state agencies,*
34 *for the biennial period ending June 30, 1999, the sum of \$100,000.*

35

1 SECTION 13. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
2 authorized by this Act shall be limited to the appropriation for such agency
3 and funds made available by law for the support of such appropriations; and
4 the restrictions of the State Purchasing Law, the General Accounting and
5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
6 Procedures and Restrictions Act, or their successors, and other fiscal control
7 laws of this State, where applicable, and regulations promulgated by the
8 Department of Finance and Administration, as authorized by law, shall be
9 strictly complied with in disbursement of said funds.

10

11 SECTION 14. LEGISLATIVE INTENT. It is the intent of the General
12 Assembly that any funds disbursed under the authority of the appropriations
13 contained in this Act shall be in compliance with the stated reasons for which
14 this Act was adopted, as evidenced by the Agency Requests, Executive
15 Recommendations and Legislative Recommendations contained in the budget
16 manuals prepared by the Department of Finance and Administration, letters, or
17 summarized oral testimony in the official minutes of the Arkansas Legislative
18 Council or Joint Budget Committee which relate to its passage and adoption.

19

20 SECTION 15. CODE. All provisions of this Act of a general and
21 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the
22 Arkansas Code Revision Commission shall incorporate the same in the Code.

23

24 SECTION 16. SEVERABILITY. If any provision of this Act or the
25 application thereof to any person or circumstance is held invalid, such
26 invalidity shall not affect other provisions or applications of the Act which
27 can be given effect without the invalid provision or application, and to this
28 end the provisions of this Act are declared to be severable.

29

30 SECTION 17. GENERAL REPEALER. All laws and parts of laws in conflict
31 with this Act are hereby repealed.

32

33 SECTION 18. EMERGENCY CLAUSE. It is hereby found and determined by the
34 Eighty-First General Assembly, that the Constitution of the State of Arkansas
35 prohibits the appropriation of funds for more than a two (2) year period; that

1 the effectiveness of this Act on July 1, 1997 is essential to the operation of
2 the agency for which the appropriations in this Act are provided, and that in
3 the event of an extension of the Regular Session, the delay in the effective
4 date of this Act beyond July 1, 1997 could work irreparable harm upon the
5 proper administration and provision of essential governmental programs.
6 Therefore, an emergency is hereby declared to exist and this Act being
7 necessary for the immediate preservation of the public peace, health and
8 safety shall be in full force and effect from and after July 1, 1997.
