24	reports, is amended to add the following new subsection:
25	${}^{\varnothing}(extsf{c})$ Whenever the name of a public servant will appear in an activity
26	report of a lobbyist, the lobbyist shall notify the public servant and provide
27	him or her the information being reported. The lobbyist shall mail or deliver
28	the notification to the public servant not later than seven (7) working days
29	prior to the date for filing the activity report. $``$

31	SECTION 2. All provisions of this act of a general and permanent nature
32	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
33	Revision Commission shall incorporate the same in the Code.

35	SECTION 3. If any provision of this act or the application thereof to
36	any person or circumstance is held invalid, such invalidity shall not affect
