20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code 25-1-105 is amended to read as follows:

23 "25-1-105. Annual reports.

24 (a) Each state board or commission created by law shall file with the
25 Legislative Council an annual mission statement describing the scope,
26 function, public purpose, specific goals and objectives, and duties of the
27 board or commission and an annual report summarizing the boards or
28 commissions activity during the previous twelve months. The filings shall be
29 made available to the Governor upon his request.

30 SECTION 2. All provisions of this act of a general and permanent nature
31 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
32 Revision Commission shall incorporate the same in the Code.

33

34 SECTION 3. If any provision of this act or the application thereof to
35 any person or circumstance is held invalid, such invalidity shall not affect
36 other provisions or applications of the act which can be given effect without

1 the invalid provision or application, and to this end the provisions of this
2 act are declared to be severable.

3

4 SECTION 4. All laws and parts of laws in conflict with this act are
5 hereby repealed.

6

7 SECTION 5. EMERGENCY. It is hereby found and determined by the General
8 Assembly that the present law requiring annual mission statements and activity
9 statements by state boards and commissions does not specify the timeframe
10 within which such reports must be filed; this act so provides; and that until
11 this act becomes effective, confusion will exist as to when those filings are
12 required. Therefore an emergency is declared to exist and this act being
13 immediately necessary for the preservation of the public peace, health and
14 safety shall become effective on the date of its approval by the Governor. If
15 the bill is neither approved nor vetoed by the Governor, it shall become
16 effective on the expiration of the period of time during which the Governor
17 may veto the bill. If the bill is vetoed by the Governor and the veto is
18 overridden, it shall become effective on the date the last house overrides the
19 veto.
