All provisions of this act of a general and permanent 27 nature are amendatory to the Arkansas Code of 1987 Annotated and the 28 Arkansas Code Revision Commission shall incorporate the same in the 29 Code. 30 SECTION 6. If any provision of this act or the application 32 thereof to any person or circumstance is held invalid, such invalidity 33 shall not affect other provisions or applications of the act which can 34 be given effect without the invalid provision or application, and to 35 this end the provisions of this act are declared to be severable. 36
