16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Arkansas Code § 8-6-1003 is amended to read as follows:  
19 "§ 8-6-1003. Landfill disposal fees.

20 (a)(1) In addition to any other fee provided by law, there is imposed  
21 on each landfill permittee a landfill disposal fee of fifteen cents (15¢) for  
22 each uncompacted cubic yard of solid waste and thirty cents (30¢) for each  
23 compacted cubic yard of solid waste received at the landfill.

24 (2) If a landfill permittee chooses to operate on a weight basis,  
25 the landfill disposal fee shall be one dollar (\$1.00) for each ton of solid  
26 waste received at the landfill.

27 ~~(b)(1) In addition to any other fee provided by law, except as stated~~  
28 ~~in subsection (a) of this section, for all solid waste generated and~~  
29 ~~transported within the state but not disposed of in a solid waste facility~~  
30 ~~within the state there is imposed on each transporter of such solid waste in~~  
31 ~~Arkansas a solid waste transportation fee of fifteen cents (15¢) for each~~  
32 ~~uncompacted cubic yard of solid waste and thirty cents (30¢) for each compacted~~  
33 ~~cubic yard of solid waste transported in the state but disposed of outside the~~  
34 ~~state.~~

35 ~~(2) If a transporter of such solid waste chooses to operate on a weight~~  
36 ~~basis, the solid waste transportation fee shall be one dollar (\$1.00) for each~~

1 ~~ton of such solid waste transported.~~

2 ~~—— (c) (b)~~ The landfill permittee referenced in subsection (a) of this  
3 section ~~and the solid waste transporter referenced in subsection (b) of this~~  
4 ~~section~~ shall use the weight basis in determining the fee for the disposal or  
5 transportation of ash."

7 SECTION 2. All provisions of this act of a general and permanent nature  
8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
9 Revision Commission shall incorporate the same in the Code.

10

11 SECTION 3. If any provision of this act or the application thereof to  
12 any person or circumstance is held invalid, such invalidity shall not affect  
13 other provisions or applications of the act which can be given effect without  
14 the invalid provision or application, and to this end the provisions of this  
15 act are declared to be severable.

17 SECTION 4. All laws and parts of laws in conflict with this act are  
18 hereby repealed.
