- 8 (a) The original evidences of indebtedness, including documents prepared
- 9 in connection with purchasing procedure, and all original contracts, invoices,
- 10 statements, receipts, petty cash tickets, bank statements, cancelled checks
- 11 drawn upon bank accounts, and other original supporting papers shall be
- 12 retained in the permanent file of the business office of each state agency or
- 13 attached to the office copy of the agencys voucher. These documents shall be
- 14 kept in a safe place subject to audit and shall not be destroyed until
- 15 authorization is given for their destruction by the Legislative Auditor.
- 16 (b) With the approval of the Legislative Auditor of the state, a state
- 17 agency may retain evidences, to satisfy record retention policies, of
- 18 indebtedness and other contracts, invoices, statements, receipts, petty cash
- 19 tickets, bank statements, cancelled checks drawn upon bank accounts, and other
- 20 supporting papers by microform or a form of stored images in a computer system
- 21 or other form of computer technology in lieu of retaining the originals of
- 22 such documents."

- 24 SECTION 3. All provisions of this act of a general and permanent nature
- 25 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 26 Revision Commission shall incorporate the same in the Code.

- 28 SECTION 4. If any provision of this act or the application thereof to
- 29 any person or circumstance is held invalid, such invalidity shall not affect
- 30 other provisions or applications of the act which can be given effect without
- 31 the invalid provision or application, and to this end the provisions of this
- 32 act are declared to be severable.

- 34 SECTION 5. All laws and parts of laws in conflict with this act are
- 35 hereby repealed.
