If any provision of this Act or the 26 application thereof to any person or circumstance is held invalid, such 27 invalidity shall not affect other provisions or applications of the Act which 28 can be given effect without the invalid provision or application, and to this 29 end the provisions of this Act are declared to be severable.

31 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict 32 with this Act are hereby repealed.
