18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19	
20	SECTION 1. Arkansas Code 12-27-107(d) is amended to read as follows:
21	"(d) Subject to the rules, regulations, policies, and procedures
22	prescribed by the Board of Correction and Community Punishment, the director
23	shall:
24	(1) Administer the department and supervise the administration of
25	all institutions, facilities, and services under the department's
26	jurisdiction;
27	(2) Employ such personnel as are required in the administration
28	of the provisions of this act, provided that the employment of personnel shall
29	be in accordance with the applicable laws and personnel regulations of the
30	state;
31	(3) Institute programs for the training and development of
32	personnel within the department and have authority to suspend, discharge, or
33	otherwise discipline personnel in accordance with policies prescribed by the
34	board;
35	(4) Make an annual report to the Board of Correction and
36	Community Punishment, which will be forwarded to the Governor and the General

- 1 Assembly, on the work of the department, including statistics and other data,
- 2 income derived by the department from agriculture, livestock, and other
- 3 farming activities and from prison inmates' activities, a summary of
- 4 expenditures of the department, and progress reports regarding internal issues
- 5 such as inmate discipline, utilization of programming, facilities and bed
- 6 space utilization, upkeep issues, and construction needs; and
- 7 (5) Cooperate with the Department of Community Punishment, the
- 8 Post Prison Transfer Board, the Arkansas Sentencing Commission, judicial
- 9 districts, counties, and municipalities to provide the guidance and services
- 10 required to ensure a full range of correctional options for the state as a
- 11 whole.; and
- 12 (6) Designate those employees of the department who shall have
- 13 the powers of peace officers in the enforcement of criminal laws to the extent
- 14 they apply to employees, inmates and persons on Arkansas Department of
- 15 Correction property, or while participating in the search and capture of an
- 16 inmate who has escaped custody, or while assisting law enforcement officers in
- 17 the search and capture of any fugitives or escapee from another jurisdiction."

- 19 SECTION 2. All provisions of this act of a general and permanent nature
- 20 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 21 Revision Commission shall incorporate the same in the Code.

- 23 SECTION 3. If any provision of this act or the application thereof to
- 24 any person or circumstance is held invalid, such invalidity shall not affect
- 25 other provisions or applications of the act which can be given effect without
- 26 the invalid provision or application, and to this end the provisions of this
- 27 act are declared to be severable.

- 29 SECTION 4. All laws and parts of laws in conflict with this act are
- 30 hereby repealed.
