10 "AN ACT TO AMEND THE ARKANSAS CODE TO PROVIDE FOR
11 CHANGES TO PENALTIES FOR ALCOHOL-RELATED DRIVING
12 OFFENSES REQUIRED BY FEDERAL LAW; TO PROVIDE A PENALTY
13 FOR USING A FICTITIOUS DRIVER'S LICENSE; TO REQUIRE A
14 COURT ORDER FOR A DRIVER'S LICENSE NAME CHANGE; TO
15 CLARIFY THE PENALTIES FOR THE OFFENSE OF REFUSAL TO
16 SUBMIT TO A TEST TO DETERMINE BLOOD ALCOHOL CONTENT;
17 TO MAKE CHANGES AND CORRECTIONS TO ADMINISTRATIVE
18 DRIVER'S LICENSE SUSPENSION PROCEDURES AFFECTING

28 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
29

30 SECTION 1. Arkansas Code 27-16-903(a) is amended to read as follows:

31 "(a) The office is authorized to cancel any driver's license or
32 identification card upon determining that the licensee was not entitled to the
33 issuance of it under this chapter or that the ~~licensee~~ applicant failed to
34 give the required or correct information in his application or committed any
35 fraud in making the application, or upon determining that the licensee
36 possessed, used, or created a forged, altered or fraudulent drivers license.

1 Upon cancellation of any such license the office may additionally suspend or
2 revoke any validly issued license of any licensee found in possession of an
3 invalid license or who has caused or assisted in the issuance of an invalid
4 license. The decision to suspend or revoke the original license of the
5 licensee shall be made in accordance with the provisions of §§ 27-16-907 and
6 27-16-912."

7

8 SECTION 2. Arkansas Code 27-16-506 is amended to read as follows:

9 "(a) Whenever any person after applying for or receiving a driver's
10 license shall move from the address named in such application or in the
11 license issued to him, or when the name of a licensee is changed by marriage
12 or otherwise, such person shall, within ten (10) days thereafter, notify the
13 office in writing of his old and new addresses or of his former and new names
14 and of the number of any license then held by him.

15 (b) No change of name shall be on a driver's license unless the
16 application for the change is accompanied by a recorded marriage license, a
17 court order or a divorce decree changing the driver's name."

18

19 SECTION 3. Arkansas Code 27-23-112(a) is amended to read as follows:

20 "(a)(1) Disqualification of Offenses. Any person shall be disqualified
21 from driving a commercial motor vehicle for the periods of time set out within
22 and in accordance with the provisions of § 27-16-915 regarding a holder of a
23 commercial driver's license issued such a license under this chapter, or for a
24 period of not less than one (1) year if convicted or disqualified by the
25 Office of Driver Services of the Department of Finance and Administration
26 administratively as provided by § 5-65-402 of a first violation of:

27 (A) Driving a commercial motor vehicle while intoxicated;

28 (B) Driving a commercial motor vehicle while the person's
29 blood alcohol concentration is four one-hundredths of one percent (0.04%) or
30 more;

31 (C) Leaving the scene of an accident involving a commercial
32 motor vehicle driven by the person;

33 (D) Using a commercial motor vehicle in the commission of
34 any felony as defined in this chapter; or

35 (E) Refusal to submit to a test to determine the driver's
36 blood alcohol concentration while driving a commercial motor vehicle.

1 (2) If any of the above violations occurred while transporting a
2 hazardous material required to be placarded, the person shall be disqualified
3 from driving a commercial motor vehicle for a period of not less than three
4 (3) years."

5
6 SECTION 4. Arkansas Code 27-23-112(b) is amended to read as follows:

7 "(b) A person shall be disqualified from driving a commercial motor
8 vehicle for life if convicted or disqualified by the Office of Driver Services
9 of the Department of Finance and Administration administratively as provided
10 by § 5-65-402 of two (2) or more violations of any of the offenses specified
11 in subsection (a) of this section, or any combination of those offenses,
12 arising from two (2) or more separate incidents. Only offenses committed
13 after January 1, 1990, can be considered in connection with such
14 disqualification for life."

15
16 SECTION 5. Arkansas Code 27-23-114(c) is amended to read as follows:

17 "(c) (1) A law enforcement officer having reasonable cause to believe the
18 person to have been driving a commercial motor vehicle while intoxicated or
19 driving a commercial motor vehicle while the person's blood alcohol
20 concentration was four hundredths of one percent (0.04%) or more shall have
21 the authority to administer or have administered a chemical test to determine
22 the person's blood alcohol concentration. The chemical test authorized shall
23 be identical to and under the same standards of the test given to persons
24 under the Omnibus DWI Act, § 5-65-101 et seq.

25 (2) At the time of arrest for subsection (a)(1), (a)(2), or (a)(5)
26 of this section the law enforcement officer shall seize the driver's license
27 of the arrested person as provided by § 5-65-402 and the Office of Driver
28 Services of the Department of Finance and Administration shall disqualify the
29 driving privileges of the arrested person as provided by § 27-23-112, under
30 the procedure in § 5-65-402 and the arrested person shall have the same right
31 to administrative and judicial review provided in § 5-65-402."

32
33 SECTION 6. Arkansas Code 27-23-114 is amended to add a new subsection to
34 read as follows:

35 "(f) The court upon determining that the driver has violated (a)(1) or
36 (a)(2) of this section previously or has been previously convicted of

1 violating § 5-65-103 or § 5-65-303 shall order an assessment of the driver's
2 degree of repeated alcohol abuse and shall order treatment for alcohol abuse
3 as a condition of sentencing if appropriate."
4

5 SECTION 7. Arkansas Code 27-23-114 is amended to add a new subsection to
6 read as follows:

7 "(g) The court upon determining that the driver has violated (a)(1) or
8 (a)(2) of this section previously or has been previously convicted of
9 violating § 5-65-103 or § 5-65-303 may order the driver to perform no less
10 than thirty (30) days of community service in lieu of imprisonment for a
11 second offense or no less than sixty (60) days of community service in lieu of
12 imprisonment for a third or subsequent offense."
13

14 SECTION 8. Arkansas Code 27-23-115 is amended to read as follows:

15 "27-23-115. Implied consent requirements for commercial motor vehicle
16 drivers.

17 (a) A person who drives a commercial motor vehicle within this state
18 shall be deemed to have given consent, subject to the provisions of § 5-65-
19 202, to take a test or tests of that person's blood, breath, or urine for the
20 purpose of determining that person's blood alcohol concentration or the
21 presence of other drugs.

22 (b) A test or tests may be administered at the direction of a law
23 enforcement officer who, after stopping or detaining the commercial motor
24 vehicle driver, has probable cause to believe that driver was driving a
25 commercial motor vehicle while having alcohol in his or her system. It shall
26 be unlawful and punishable as provided in this chapter for any person so
27 stopped or detained to refuse to submit to such test or tests to determine
28 that person's blood alcohol concentration or the presence of other drugs.

29 (c) A person requested to submit to a test as provided in subsection
30 (a) of this section must be warned by the law enforcement officer requesting
31 the test that a refusal to submit to the test will result in that person being
32 disqualified from operating a commercial motor vehicle under § 27-23-112 and §
33 5-65-402.

34 (d) If the person is under arrest and refuses testing, none shall be
35 given, and the person's commercial driver license shall be seized by the law
36 enforcement officer, and the officer shall immediately deliver to the person

1 whose license was seized a temporary commercial driving permit ~~which shall~~
 2 ~~expire on the person's date of arraignment~~ as provided by § 5-65-402 and
 3 shall cite the person for their refusal to submit to the test.

4 (e) The arresting officer shall remit the seized commercial driver
 5 license to the court, ~~and upon arraignment, the judge shall issue that person~~
 6 ~~a temporary commercial driving permit to expire on the date of trial~~ Office of
 7 Driver Services of the Department of Finance and Administration as provided by
 8 § 5-65-402.

9 (f) ~~If the judge determines at trial that the officer had reasonable~~

25 the invalid provision or application, and to this end the provisions of this
26 act are declared to be severable.

27
28 SECTION 25. All laws and parts of laws in conflict with this act are
29 hereby repealed.
