32	Legislative Council, in markup format, the changes made pursuant to this act.

34	(30) calendar days after the commission instructs the publisher to make the				
35	changes.

1	SECTION 5. Special Language. The provisions of this Act are not to be
2	incorporated into the Arkansas Code Annotated nor published separately as
3	special, local, and temporary law.
4	
5	SECTION 6. All provisions of this act of a general and permanent nature
6	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
7	Revision Commission shall incorporate the same in the Code.
8	
9	SECTION 7. If any provision of this act or the application thereof to
10	any person or circumstance is held invalid, such invalidity shall not affect
11	other provisions or applications of the act which can be given effect without
12	the invalid provision or application, and to this end the provisions of this
13	act are declared to be severable.
14	
15	SECTION 8. All laws and parts of laws in conflict with this act are
16	hereby repealed.
17	
18	SECTION 9. <u>EMERGENCY CLAUSE</u> . It is hereby found and determined by the
19	$\underline{\hbox{\bf Eighty-second General Assembly that the name changes contemplated by this act}}\\$
20	should be made and published at the earliest possible date in order to avoid
21	confusion in the law among the members of the bar and the citizens of
22	Arkansas. Therefore, an emergency is declared to exist and this act being
23	immediately necessary for the preservation of the public peace, health and
24	safety shall become effective on the date of its approval by the Governor. If
25	the bill is neither approved nor vetoed by the Governor, it shall become
26	effective on the expiration of the period of time during which the Governor
27	may veto the bill. If the bill is vetoed by the Governor and the veto is
28	overridden, it shall become effective on the date the last house overrides the
29	<u>veto.</u>
