There is 24 hereby appropriated, to the Department of Finance and Administration -25 Disbursing Officer, to be payable from the General Improvement Fund or its 26 successor fund or fund accounts, for assisting the city of Dewitt in defraying 27 28 the costs of constructing a community/recreation center for the biennial 29 period ending June 30, 2001, the sum of\$100,000. 30 31 SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects 32 described herein in excess of the State Treasury funds actually available 33 therefor as provided by law. Provided, however, that institutions and 34 35 agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or 36

funds, or both available to it, for the purpose of supplementing the State 1

- 3 enumerated herein. Provided further, that the appropriations and funds

- Operations of the agency or institutions receiving appropriation herein shall 5
- not be used for any of the purposes as appropriated in this act. 6
- 7 (B) The restrictions of any applicable provisions of the State Purchasing
- 8 Law, the General Accounting and Budgetary Procedures Law, the Revenue
- 9 Stabilization Law and any other applicable fiscal control laws of this State
- and regulations promulgated by the Department of Finance and Administration, 10
- 11 as authorized by law, shall be strictly complied with in disbursement of any

- SECTION 5. SEVERABILITY. If any provision of this act or the application

1	Eighty-second General Assembly, that the Constitution of the State of Arkansas
