Arkansas Code 9-28-407(a) is amended to read as follows: 21 22 "(a) It shall be unlawful for any person, partnership, group, corporation, association, or other entity or identifiable group of entities 23 having a coordinated ownership of controlling interest, to operate or assist 24 in the operation of a child welfare agency which has not been licensed by the 25 board from licensing pursuant to this subchapter. This license shall be 26 required in addition to any other license required by law for all entities 27 28 that fit the definition of a child welfare agency and not specifically 29 exempted except that no non psychiatric residential treatment facility or 30 agency licensed or exempted pursuant to this subchapter shall be deemed to 31 fall within the meaning of Arkansas Code 20-10-101(7) for any purpose. Any child welfare agency licensed or permitted by the Child Welfare Review Board 32 as of 1999 is exempted from the requirements of law (1) to obtain a license or 33 permit from the Office of Long-Term Care and (2) to obtain a permit from the 34 35 Health Services Agency and Commission.
