20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - ALL DIVISIONS. There is hereby established
23 for the Arkansas Economic Development Commission for the 1999-2001 biennium,
24 the following maximum number of regular employees whose salaries shall be
25 governed by the provisions of the Uniform Classification and Compensation Act
26 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
27 thereto. Provided, however, that any position to which a specific maximum
28 annual salary is set out herein in dollars, shall be exempt from the
29 provisions of said Uniform Classification and Compensation Act. All persons
30 occupying positions authorized herein are hereby governed by the provisions of
31 the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
32 101), or its successor.

36 may be transferred to item (02), Extra Help or item (05), Maintenance and

9 PROVISION - INDUSTRY TRAINING PROGRAM. During either fiscal year of the ~~1997-~~
10 ~~99~~ 1999-2001 biennium any savings accomplished in line item (02) of Section ~~16~~
11 11 of this Act, Extra Help, may be transferred to line item (05) of Section ~~16~~
12 11 of this Act, Maintenance and General Operation after prior review by the
13 ~~Arkansas~~ Legislative Council or Joint Budget Committee.

15 SECTION 37. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RURAL
17 DEVELOPMENT. From the funds appropriated for COMMUNITY DEVELOPMENT GRANTS in
18 this Act for Community Assistance-Federal, the Arkansas Economic Development
19 Commission (AEDC) shall allocate \$500,000 per fiscal year to the Rural
20 Development Set-Aside from the Economic Development Set-Aside, as defined in
21 AEDC's Consolidated Plan filed with the federal Department of Housing and
22 Urban Development. Funds allocated to the Rural Development Set-Aside are to
23 be used exclusively for grants to rural communities as defined in the

34 SECTION 39. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
35 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GRANT REVIEW.
36 The Arkansas Economic Development Commission (AEDC) shall review all

1 applications for grant funds from the Rural Development Set-Aside and shall
2 certify to the Office of Rural Advocacy Commission those applications eligible
3 for grant funds under AEDC and federal guidelines. The Office of Rural
4 Advocacy alone shall decide which grant applications will be funded, and AEDC
5 shall disburse grant funds from the Rural Development Set-Aside to those
6 applicants receiving final approval by the Office of Rural Advocacy
7 Commission. AEDC and the Office of Rural Advocacy shall promulgate rules and
8 regulations governing the application for and disbursement of grant funds from

12 SECTION 40. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
13 by this act shall be limited to the appropriation for such agency and funds
14 made available by law for the support of such appropriations; and the
15 restrictions of the State Purchasing Law, the General Accounting and Budgetary
16 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
17 and Restrictions Act, or their successors, and other fiscal control laws of
18 this State, where applicable, and regulations promulgated by the Department of
19 Finance and Administration, as authorized by law, shall be strictly complied
20 with in disbursement of said funds.

21

22 SECTION 41. LEGISLATIVE INTENT. It is the intent of the General Assembly
23 that any funds disbursed under the authority of the appropriations contained
24 in this act shall be in compliance with the stated reasons for which this act
25 was adopted, as evidenced by the Agency Requests, Executive Recommendations
26 and Legislative Recommendations contained in the budget manuals prepared by
27 the Department of Finance and Administration, letters, or summarized oral
28 testimony in the official minutes of the Arkansas Legislative Council or Joint
29 Budget Committee which relate to its passage and adoption.

30

31 SECTION 42. CODE. All provisions of this Act of a general and permanent
32 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
33 Code Revision Commission shall incorporate the same in the Code.

34

35 SECTION 43. SEVERABILITY. If any provision of this act or the application
36 thereof to any person or circumstance is held invalid, such invalidity shall

1 not affect other provisions or applications of the act which can be given
2 effect without the invalid provision or application, and to this end the
3 provisions of this act are declared to be severable.

4
5 SECTION 44. GENERAL REPEALER. All laws and parts of laws in conflict with
6 this act are hereby repealed.

7
8 SECTION 45. EMERGENCY CLAUSE. It is hereby found and determined by the
9 Eighty-second General Assembly, that the Constitution of the State of Arkansas
10 prohibits the appropriation of funds for more than a two (2) year period; that
11 the effectiveness of this Act on July 1, 1999 is essential to the operation of
12 the agency for which the appropriations in this Act are provided, and that in
13 the event of an extension of the Regular Session, the delay in the effective
14 date of this Act beyond July 1, 1999 could work irreparable harm upon the
15 proper administration and provision of essential governmental programs.
16 Therefore, an emergency is hereby declared to exist and this Act being
17 necessary for the immediate preservation of the public peace, health and
18 safety shall be in full force and effect from and after July 1, 1999.
