"AN ACT TO AMEND ARKANSAS CODE 27-14-902 TO PROVI DE FOR TRANSFER OF MDTOR VEHI CLE REG STRATI ON AND LI CENSE PLATES TO OR FROM LEASED NONCOMMERCI AL MDTOR VEHI CLES; TO AMEND ARKANSAS CODE 27-14-1012 TO REQUI RE VEHI CLE REG STRATI ON RENEWAL NOTI CES BE MAI LED NOT LESS THAN THI RTY ( 30) DAYS PRI OR TO REGI STRATI ON EXPI RATI ON; AND FOR OTHER PURPOSES. "

> "TO ALLOW THE TRANSFER OF MDTOR VEHI CLE LI CENSE PLATES TO LEASED VEH CLES AND TO REQUI RE REGI STRATI ON RENEWAL NOTI CES BE MAI LED NOT LESS THAN 30 DAYS PRI OR TO EXPI RATI ON. "

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTI ON 1. Arkansas Code § $27-14-902$ is amended to read as follows:
"27-14-902. Transfer or assi gnment by owner generally.
(a)(1) Whenever the owner or lessee of a registered vehicle transfers or assigns his title, or interest thereto, the registration of the vehicle shall expire.
(2) The owner shall remove the license plate or pl ates and any pl ate sticker, metal tab, or decal therefromand forward themto the office, or he may have such pl ate or pl ates and pl ate sticker, metal tab, or decal, and the regi stration number thereon, assigned to another vehicle, upon payment of the fees required by Iaw and subject to the rules and regul ations of the
of fice.
(b)(1) The owner or lessee shall pay a transfer fee of one dollar (\$1.00).
(2) If the fee for regi stration and licensing the vehicle to be regi stered is greater than the registration fee paid for the vehicle originally licensed, then the office shall, in addition, collect an amount equal to the excess payable for the vehicle to be regi stered.
(3) No ref und will be due in the event that the fee for regi stration and licensing the vehicle to be regi stered is less than that represented by the license to be transferred.
(c) The owner or lessee shall pay any additional fee which shall be requi red under the registration laws of this state.
(d) The owner shall endorse an assi gnment and warranty of title upon the certificate of title for the vehicle, and he shall del iver the certificate of title to the purchaser or transferee at the time of delivering the vehicle, except as provi ded in §§ 27-14-906 and 27-14-909."

SECTI ON 2. Arkansas Code § 27-14-1012(b), regarding the regi stration or renewal of motor vehicle license plates, is amended to read as follows:
"(b) Sixty (60) Not less than thirty (30) days before the expiration of the license, the director shall notify the owner of a regi stered motor vehicle subject to this subchapter at the last address of the owner of the mot or vehicle as such owner's name and address appear on the records of the Office of Mbtor Vehicle, but the director is not required to go beyond the face of the last regi stration statement."

SECTI ON 3. All provisions of this act of a general and perment nature are amendat ory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revi si on Comission shall incorporate the same in the Code.

SECTI ON 4. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect ot her provisions or applications of the act which can be given effect without the invalid provision or aplication, and to this end the provisions of this act are decl ared to be severable.

SECTI ON 5. All I aws and parts of laws in conflict with this act are her eby repeal ed.
