8	functions which had been performed by employees of the Division of Youth
9	Services of the Department of Human Services shall include a performance

12	performance indicators of the contract and how the state agency intends to
13	evaluate the service provided.
14	(b) The Department of Human Services shall report to the Senate Interim
15	Committee on Children and Youth and the House Interim Committee on Aging,
16	Children and Youth, Legislative and Military Affairs or appropriate
17	subcommittees thereof at least annually regarding the performance evaluation
18	of each contract.

20	SECTION 3. All provisions of this act of a general and permanent nature
21	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
22	Revision Commission shall incorporate the same in the Code.

24	SECTION 4. If any provision of this act or the application thereof to
25	any person or circumstance is held invalid, such invalidity shall not affect
26	other provisions or applications of the act which can be given effect without
27	the invalid provision or application, and to this end the provisions of this
28	act are declared to be severable.
29	
30	SECTION 5. All laws and parts of laws in conflict with this act are
31	hereby repealed.
