Right to be accompanied by service animal; Penalty and 3 restitution for killing or injuring a service animal or search and rescue dog. (a) Every visually handicapped, hearing impaired, or other physically 4 5 disabled person shall have the right to be accompanied by a service animal especially trained to do work or perform tasks for the benefit of an 6 7 individual with a disability in or upon any and all public ways, public places, and other public accommodations and housing accommodations prescribed 8 9 in § 20-14-303 and shall not be required to pay any extra fee or charge for 10 the service animal. (b) However, any visually handicapped, hearing impaired, or other 11 12 physically disabled person accompanied by a service animal in any public way, 13 public place, public accommodation, or housing accommodation shall be liable for any damage caused to the premises or facilities by the animal. 14 15 (c) For purposes of this section, 'search and rescue dog' means any dog: (1) in training for or trained for the purpose of search and rescue, (2) 16 17 owned by an independent handler or member of a search and rescue team, and (3) 18 used in conjunction with local law enforcement or emergency services 19 organizations, for the purpose of locating missing persons or evidence of 20 arson.
