## For An Act To Be Entitled

10 "AN ACT TO AMEND ARKANSAS CODE 7-5-109 TO ESTABLISH A  
11 UNIFORM COST FOR PRINTED VOTER REGISTRATION LISTS; AND  
12 FOR OTHER PURPOSES. "

### Subtitle

14 "TO AMEND ARKANSAS CODE 7-5-109 TO  
15 ESTABLISH A UNIFORM COST FOR PRINTED  
16 VOTER REGISTRATION LISTS. "

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code 7-5-109 is amended to read as follows:

23 "7-5-109. Computerized voter registration lists.

24 (a) The county clerks of the several counties of the state may  
25 reproduce the registered voter list maintained by the county clerk in any  
26 format that the office of the county clerk is capable of providing.

27 (b) The county clerks shall be entitled to a fee in connection with the  
28 preparation of any registered voter list that shall reimburse the county clerk  
29 for reproduction expenses. The value of office equipment previously secured  
30 for the office of the county clerk shall not be considered when determining  
31 the amount of this fee.

32 (c) Every county clerk who maintains on computer the list of registered  
33 voters within the county shall on request provide the list on computer disk or  
34 tape. The list shall include at least the name, address, and precinct number  
35 of the voters. If a printed list is requested, the cost of the list may be no  
36 more than two cents (\$0.02) per name and address.

1 (d)(1) The fee for a list, on computer disk or tape, of one (1) to five  
2 thousand (5,000) registered voters ~~shall~~ may be up to ten dollars (\$10.00).

3 (2) The fee for a list, on computer disk or tape, of five  
4 thousand and one (5,001) to twenty-five thousand (25,000) registered voters  
5 ~~shall~~ may be up to twenty-five dollars (\$25.00).

6 (3) The fee for a list, on computer disk or tape, of more than  
7 twenty-five thousand (25,000) registered voters ~~shall~~ may be up to fifty  
8 dollars (\$50.00)."

9  
10 SECTION 2. All provisions of this act of a general and permanent nature  
11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
12 Revision Commission shall incorporate the same in the Code.

13  
14 SECTION 3. If any provision of this act or the application thereof to  
15 any person or circumstance is held invalid, such invalidity shall not affect  
16 other provisions or applications of the act which can be given effect without  
17 the invalid provision or application, and to this end the provisions of this  
18 act are declared to be severable.

19  
20 SECTION 4. All laws and parts of laws in conflict with this act are  
21 hereby repealed.
