Arkansas Code 24-10-504(a), regarding the forfeiture of 23 service credit by former members of the Local Police and Fire Retirement 24 System (LOPFI), is amended to read as follows: 25 "(a)(1) When a member is no longer employed by any employer in covered 26 employment, he shall thereupon cease to be a member of the system. 27 28 (2) Except as otherwise provided in this chapter, upon 29 termination of his membership, his credited service shall be forfeited by him. (3) If the person is not a retirant and becomes reemployed by any 30 31 employer in covered employment, he shall again become a member of the system. (4) Should the Upon his reemployment or employment occur within a 32 period of four (4) years from and after the date his membership last 33 terminated, his credited service last forfeited by him shall be restored to 34 35 his credit, but only if he returns to the system the amount, if any, he withdrew therefrom, together with regular interest from the date of withdrawal 36

3	SECTION 2. <u>No benefit enhancement provided for by this act shall be</u>
4	<u>implemented if it would cause the publicly supported retirement system's</u>
5	unfunded actuarial accrued liabilities to exceed a thirty (30) year
6	amortization. No benefit enhancement provided for by this act shall be
7	implemented by any publicly supported system which has unfunded actuarial
8	accrued liabilities being amortized over a period exceeding thirty (30) years
9	until the unfunded actuarial accrued liability is reduced to a level less than
10	the standards prescribed by Arkansas Code, Title 24.
11	
12	SECTION 3. All provisions of this act of a general and permanent nature
13	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
14	Revision Commission shall incorporate the same in the Code.
15	
16	SECTION 4. If any provision of this act or the application thereof to
17	any person or circumstance is held invalid, such invalidity shall not affect
18	other provisions or applications of the act which can be given effect without
19	the invalid provision or application, and to this end the provisions of this
20	act are declared to be severable.
21	
22	SECTION 5. All laws and parts of laws in conflict with this act are
23	hereby repealed.
