7 SECTION 10. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds 8 9 made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary 10 11 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures 12 and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of 13 14 Finance and Administration, as authorized by law, shall be strictly complied 15 with in disbursement of said funds.

17 SECTION 11. LEGISLATIVE INTENT. It is the intent of the General Assembly 18 that any funds disbursed under the authority of the appropriations contained 19 in this act shall be in compliance with the stated reasons for which this act 20 was adopted, as evidenced by the Agency Requests, Executive Recommendations 21 and Legislative Recommendations contained in the budget manuals prepared by 22 the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint 23 24 Budget Committee which relate to its passage and adoption.

26 SECTION 12. CODE. All provisions of this Act of a general and permanent 27 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 28 Code Revision Commission shall incorporate the same in the Code.

30 SECTION 13. SEVERABILITY. If any provision of this act or the application 31 thereof to any person or circumstance is held invalid, such invalidity shall 32 not affect other provisions or applications of the act which can be given 33 effect without the invalid provision or application, and to this end the 34 provisions of this act are declared to be severable except that provided in 35 Section 8 (c) herein.

1	SECTION 14. GENERAL REPEALER. All laws and parts of laws in conflict with
2	this act are hereby repealed.

4	SECTION 15. EMERGENCY CLAUSE. It is hereby found and determined by the
5	Eighty-second General Assembly, that the Constitution of the State of Arkansas
6	prohibits the appropriation of funds for more than a two (2) year period; that
7	the effectiveness of this Act on July 1, 1999 is essential to the operation of
8	the agency for which the appropriations in this Act are provided, and that in
9	the event of an extension of the Regular Session, the delay in the effective
