25	SECTION 1. Arkan	sas Code 2-36-302 is amended to read as	s follows:

27	(a)(1) There is	created the Northeast Arkansas Distric	ct Fair Advisory
28	Board to be composed o	f thirty-two (32) <u>thirty-one (31)</u> membe	ers:

11	person from that county to be a member of the Northeast Arkansas District Fair		
12	Advisory Board.		
13	(B) If any county does not have a county fair board, the		
14	county judge of that county shall appoint that county's representative to the		
15	board.		
16	(3) Members of the board shall serve four-year terms, and any		
17	vacancies arising in the board membership shall be filled in the same manner		
18	as were the original appointments.		
19	(b)(1) In all matters, the fair shall be subject to the rules and		
20	regulations of the Arkansas Livestock and Poultry Commission and otherwise		
21	conducted in the same manner as other district fairs.		
22	(2)(A) The Location of the Northeast Arkansas District Fair shall		
23	be determined by the Northeast Arkansas District Fair Advisory Board under the		
24	provisions of this section.		
25	(B)(i) Determination of the location and the date of the		
26	fair shall be by a vote of at least two-thirds (2/3) of a quorum of the board.		
27	(ii) A quorum shall be seventeen (17) <u>sixteen (16)</u>		
28	members.		
29	(c) The board shall annually select a chairman from among its		
30	membership.		
31	(d) After each federal decennial census, the membership on the board		
32	shall be reapportioned among the counties listed in subsection (a) of this		
33	section in such manner as to reflect the proportionate population of each		
34	county relating to the district as a whole."		

SECTION 2. Arkansas Code 2-36-306 is amended to read as follows:

- 1 "2-36-306. North Central Arkansas District Fair and Livestock Show.
- 2 (a) There is established a district livestock show to be known as the 3 'North Central Arkansas District Fair and Livestock Show' to be located in 4 Izard County.
 - (b) Counties composing the North Central Arkansas District Fair and Livestock Show district shall be Cleburne County, Fulton County, Independence County, Izard County, Sharp County, and Stone County.
 - (c) The North Central Arkansas District Fair and Livestock Show shall enjoy the same privileges and status as previously established district livestock shows in the State of Arkansas.
 - (d)(1) There is created the North Central Arkansas District Fair Board to be composed of $\frac{1}{2} \cdot \frac{1}{2} \cdot \frac{1}{$
 - (2) The members of the board shall serve four (4) year terms and any vacancies arising in the board membership shall be filled in the same manner as were the original appointments. The terms of the initial members of the board shall be determined by lot so that the term of three (3) members expire each year."

SECTION 3. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

 SECTION 4. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 5. All laws and parts of laws in conflict with this act are hereby repealed.
