21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. REGULAR SALARIES - UTILITIES DIVISION. There is hereby
24 established for the Arkansas Public Service Commission - Utilities Division
25 for the 2001-2003 biennium, the following maximum number of regular employees
26 whose salaries shall be governed by the provisions of the Uniform
27 Classification and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its
28 successor, and all laws amendatory thereto. Provided, however, that any
29 position to which a specific maximum annual salary is set out herein in
30 dollars, shall be exempt from the provisions of said Uniform Classification
31 and Compensation Act. All persons occupying positions authorized herein are
32 hereby governed by the provisions of the Regular Salaries Procedures and
33 Restrictions Act (Arkansas Code §21-5-101), or its successor.

8 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

10 CONTINGENCY RESTRICTION. UTILITIES DIVISION. In the event of unforeseen
 11 conditions, additional appropriations become necessary that are not authorized
 12 or contemplated in Section 3 of this Act and such events make it necessary
 13 that the Public Service Commission - Utilities Division receives additional
 14 appropriations to carry out the objectives of the agency, the Director of the

9 Section 8 of this Act and specific cases, situations, and/or programs make it
10 necessary that the Arkansas Public Service Commission – Tax Division receives
11 additional appropriations to carry out the objectives of the Division, the
12 Chairman of the Arkansas Public Service Commission is hereby authorized to
13 request the approval of the Governor and the Chief Fiscal Officer of the State
14 for transfers of the appropriations provided in the Contingency Line item of
15 Section 8 of this Act to other line items within Section 8. In no event shall
16 the transfers in any fiscal year exceed the appropriations provided in the
17 Contingency Line item of Section 8 of this Act. The Governor may approve or
18 modify such request for transfer of appropriations as in his judgment he deems
19 necessary, and shall seek prior review of the Arkansas Legislative Council and
20 inform the Chief Fiscal Officer of the State. Upon notification, the Chief
21 Fiscal Officer of the State shall direct the State Auditor to process said
22 transfer upon his books in accordance with the provisions as set out herein.

23
24 The provisions of this section shall be in effect only from July 1, 2001
25 through June 30, 2003.

26
27 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RURAL AND
29 COMMUNITY LIAISON. GENERAL JOB RESPONSIBILITIES. The Rural and Community
30 Liaison will serve as a two-way communication link between the Arkansas Public
31 Service Commission and utility customers in Arkansas, particularly those in
32 rural areas. The Rural and Community Liaison is responsible for providing
33 information to communities and rural utility customers concerning utility
34 matters within the jurisdiction of the Commission. The Rural and Community
35 Liaison is also responsible for identifying questions and concerns that rural
36 utility customers may have concerning utility issues and relaying those

1 concerns to the Commissioners and the Commission Staff. In the performance of
2 these duties, the Rural and Community Liaison will work with stakeholders in
3 rural areas and communities, including legislators, civic and community
4 leaders, customers and customer groups, and rural utility personnel.

5
6 The provisions of this section shall be in effect only from July 1, 2001
7 through June 30, 2003.

8
9 SECTION 16. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
10 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES. (A) For all
11 appropriations as provided in this Act, the agency disbursing officer shall
12 monitor the level of fund balances in relation to expenditures on a monthly
13 basis. If any proposed expenditures would cause a fund balance to decline to
14 less than fifty percent (50%) of the balance available on July 1, 2001, the
15 disbursing officer shall immediately notify the executive head of the agency.

16 Prior to any obligations being made under these circumstances, the agency
17 head shall file written documentation with the Chief Fiscal Officer of the
18 State requesting approval of the expenditures. Such documentation shall
19 provide sufficient financial data to justify the expenditures and shall
20 include the following:

- 21 1) a plan that clearly indicates the specific fiscal impact of such
22 expenditures on the fund balance.
23 2) information clearly indicating and explaining what programs would be cut or
24 any other measures to be taken by the agency to restore the fund balance.
25 3) the extent to which any of the planned expenditures are for one-time costs
26 or one-time purchase of capitalized items.
27 4) a statement certifying that the expenditure of fund balances will not
28 jeopardize the financial health of the agency, nor result in a permanent
29 depletion of the fund balance.

30 (B) The Chief Fiscal Officer of the State shall review the request and
31 approve or disapprove all or any part of the request, after having sought
32 prior review by the Legislative Council.

33
34 SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
35 by this act shall be limited to the appropriation for such agency and funds
36 made available by law for the support of such appropriations; and the

1 restrictions of the State Purchasing Law, the General Accounting and Budgetary
2 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
3 and Restrictions Act, or their successors, and other fiscal control laws of
4 this State, where applicable, and regulations promulgated by the Department of
5 Finance and Administration, as authorized by law, shall be strictly complied
6 with in disbursement of said funds.

7
8 SECTION 18. LEGISLATIVE INTENT. It is the intent of the General Assembly
9 that any funds disbursed under the authority of the appropriations contained
10 in this act shall be in compliance with the stated reasons for which this act
11 was adopted, as evidenced by the Agency Requests, Executive Recommendations
12 and Legislative Recommendations contained in the budget manuals prepared by
13 the Department of Finance and Administration, letters, or summarized oral
14 testimony in the official minutes of the Arkansas Legislative Council or Joint
15 Budget Committee which relate to its passage and adoption.

16
17 SECTION 19. EMERGENCY CLAUSE. It is found and determined by the General
18 Assembly, that the Constitution of the State of Arkansas prohibits the
19 appropriation of funds for more than a two (2) year period; that the
20 effectiveness of this Act on July 1, 2001 is essential to the operation of the
21 agency for which the appropriations in this Act are provided, and that in the
22 event of an extension of the Regular Session, the delay in the effective date
23 of this Act beyond July 1, 2001 could work irreparable harm upon the proper
24 administration and provision of essential governmental programs. Therefore, an
25 emergency is hereby declared to exist and this Act being necessary for the
26 immediate preservation of the public peace, health and safety shall be in full
27 force and effect from and after July 1, 2001.
