10 AN ACT TO AUTHORIZE COLLECTORS TO RETAIN A  
11 COLLECTION FEE FOR PREPAYMENTS OF CERTAIN  
12 IMPROVEMENT DISTRICT ASSESSMENTS; AND FOR OTHER  
13 PURPOSES.

### Subtitle

15 AN ACT TO AUTHORIZE COLLECTORS TO RETAIN

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Arkansas Code 14-92-230(b)(1)(A)(ii) pertaining to  
25 collectors' fees for suburban improvement district assessments is amended to  
26 read as follows:

27 (ii) For his or her services in making the  
28 collections, including pre-payments, the collector shall receive a commission  
29 of one and one-half percent (1-1/2%). In the case of pre-payments, the  
30 maximum commission shall be the lesser of one and one-half percent (1-1/2%)  
31 or fifty dollars (\$50.00).

33 SECTION 2. Arkansas Code 14-93-121(b)(1)(A)(ii) pertaining to  
34 collectors' fees for property owners' improvement district assessments is  
35 amended to read as follows:

36 (ii) For his or her services in making the

1 collections, including pre-payments, the collector shall receive a commission  
2 of one and one-half percent (1-1/2%). In the case of pre-payments, the  
3 maximum commission shall be the lesser of one and one-half percent (1-1/2%)  
4 or fifty dollars (\$50.00).

6 SECTION 3. Arkansas Code 14-94-120(b)(1)(A)(ii) pertaining to  
7 collectors' fees for municipal property owners' improvement district  
8 assessments is amended to read as follows:

9 (ii) For his or her services in making the  
10 collections, including pre-payments, the collector shall receive a commission  
11 of one and one-half percent (1-1/2%). In the case of pre-payments, the  
12 maximum commission shall be the lesser of one and one-half percent (1-1/2%)  
13 or fifty dollars (\$50.00).
