## For An Act To Be Entitled

9 AN ACT TO RENAME THE DEPARTMENT OF COMMUNITY  
10 PUNISHMENT AS THE DEPARTMENT OF COMMUNITY CORRECTION;  
11 TO RENAME THE BOARD OF CORRECTION AND COMMUNITY  
12 PUNISHMENT AS THE BOARD OF CORRECTIONS; TO RENAME THE  
13 COMMUNITY PUNISHMENT REVOLVING FUND AS THE COMMUNITY  
14 CORRECTION REVOLVING FUND; AND FOR OTHER PURPOSES.

## Subtitle

16 AN ACT TO RENAME THE DEPARTMENT OF  
17 COMMUNITY PUNISHMENT; RENAME THE BOARD  
18 OF CORRECTION AND COMMUNITY PUNISHMENT;  
19 RENAME THE COMMUNITY PUNISHMENT  
20 REVOLVING FUND.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
25

26 SECTION 1. Legislative intent. The General Assembly, in Act 549 of  
27 1993, established the Arkansas Department of Community Punishment and  
28 delineated its purposes. Confusion in the public's perception, with regard to  
29 the purposes of the department, exists and will persist because of the  
30 inconsistency between the name of the department and its established purposes.  
31 The purpose of this act is to provide the department with a name that more  
32 accurately describes its role as an agency that is intended to fulfill the  
33 legislatively established purposes of supervision, treatment, rehabilitation,  
34 and restoration of adult offenders as useful law-abiding citizens within the  
35 community and to provide its supervisory board with a name consistent with the  
36 department's name change.

1 SECTION 2. The "Department of Community Punishment", as established in  
2 Arkansas Code 12-27-125, shall hereafter be known as the "Department of  
3 Community Correction".

4  
5 SECTION 3. The "Board of Correction and Community Punishment", as  
6 established in Arkansas Code 12-27-104 and 16-93-1203, shall hereafter be  
7 known as the "Board of Corrections".

8  
9 SECTION 4. The "Community Punishment Revolving Fund", as established in  
10 Arkansas Code 12-27-133 and 19-6-432, shall hereafter be known as the  
11 "Community Correction Revolving Fund".

12  
13 SECTION 5. (a) The Arkansas Code Revision Commission shall make  
14 appropriate name changes in the Arkansas Code to implement this act.

15 (b) The Arkansas Code Revision Commission is not required to codify  
16 this act.
